I. Preservation of Wan Chai Market Building

[LC Paper Nos. CB(2)1814/07-08(01) and CB(2)687/07-08]

Executive Director (Planning and Development) (ED(P&D)) of the Urban Renewal Authority (URA) gave a PowerPoint presentation on the proposed core elements preservation scheme of Wan Chai Market. URA proposed that, subject to detailed structural investigation, major character defining elements of the Market building will be preserved, including the major façade, the main entrance, the curved canopy and fins, and part of the front portion of the structural form. The preserved portions of the Market building would be used mainly for commercial purpose as in the approved scheme.

- 2. URA also proposed that the design of the new residential tower on top of the Market building would take into account the original architectural style of the Market. In order to keep the existing building envelope of the Market building, a smaller number of car parking spaces would be provided.
- 3. <u>Miss CHAN Yuen-han</u> expressed disappointment with the current approach which in her view failed to serve the conservation purpose for the Market as it preserved only some core elements of the Market. She considered that the Administration should explore various options of transfer of plot ratio that could be offered to the developer in return for a bigger say in the design of the development.
- 4. <u>ED(P&D)</u> said that the main characteristics of the Market building, such as the main entrance, the windows, the grey columns and staircase, which were most remembered would be preserved. <u>Principal Assistant Secretary</u> (<u>Planning & Lands</u>) 4 explained that, as the developer wanted to speed up implementation of the project to minimise impact caused by fluctuations of the market, transfer of plot ratio was not appealing to the developer as it involved a

process of negotiations and created uncertainties.

5. <u>The Chairman</u> suggested that the ceiling height of the Market should be maintained and its old floor tiles should be kept as far as possible in order to preserve its characteristics. <u>Prof Patrick LAU</u> suggested that the round corners of the Market building should be preserved. <u>ED(P&D)</u> agreed to consider these suggestions when working out the detailed design.
