# Legislative Council Panel on Housing Meeting on 7 January 2008

Thank you for your letter of 9 January. At the meeting of the Legislative Council Panel on Housing on 7 January, Members requested the Administration to provide information on the Public Housing Construction Programme. Our response is as follows.

According to the 2007/08-2011/12 Public Housing Construction Programme, the forecast new public rental housing (PRH) production in the coming five years is about 76,000 flats, with about 80% coming from the Urban/Extended Urban Districts. Please see **Annex** for details. With this level of production and the about 82,000 PRH flats estimated to be recovered during this period, the average waiting time of general family applicants for PRH can be maintained at about three years in the coming five years.

The Hong Kong Housing Authority (HA) formulates the Public Housing Construction Programme on a five-year basis. The programme will be reviewed and rolled forward annually. The production volume and programmes of the public housing development projects from 2012/13 to 2016/17 cannot be confirmed at this stage, as most of the sites for public housing development during this period are at the early planning stage and a number of issues remain to be resolved. We will closely monitor the public housing demand and continue to formulate the Public Housing Construction Programme based on the principle of maintaining the average waiting time for general family applicants at about three years.
