Proposed timing for discussion

1. Expansion of Tseung Kwan O Hospital

May 2008

Item proposed by the Administration.

2. Further discussion on mental health policy

May 2008

At the meeting on 22 November 2007, members agreed to hold another meeting to follow up the captioned subject upon receipt of the Administration's responses to the views expressed by deputations and the motion carried in three months' time.

Dr Hon Fernando CHEUNG's letter dated 27 February 2008 on the captioned subject was issued to members on 6 March 2008 [Appendix I to LC Paper No. CB(2) 1266/07-08(01)].

3. Progress report on registration of Chinese Medicine practitioners (CMPs)

May 2008

Subsequent to the meeting on 13 November 2006, the Panel has decided that the issue of providing appropriate assistance to listed CMPs seeking to obtain registration status be made a standing agenda item for discussion by the Panel every six months.

The item was last discussed by the Panel at its meeting on 12 November 2007.

4. Review of Hospital Authority's new obstetric service arrangements and the obstetric service charge for non-eligible persons

June 2008

At the meeting on 18 February 2008, the Administration agreed to revert to members on the outcome of its review on the whole package of obstetric service arrangements before the expiry of the current legislative session.

The item was last discussed by the Panel at the meeting on 8 January 2007. The Administration was requested to report to the Panel after it had completed an evaluation study of the campaign to promote healthy eating habit among school children at the end of the 2006-2007 school year and to take into account members' views and suggestions in the comprehensive review of the campaign.

9. Allocation of resources among hospital clusters by the Hospital Authority

Q3 2008

At the meeting on 14 January 2008, the Administration was requested to revert to members in six months' time on the motion carried, the development of the new internal funding allocation model, the suggestion of rotating Hospital Chief Executives (HCEs) to also serve as Cluster Chief Executive and the progress made in rotating HCEs to work at other hospitals.

10. Regulation of medical devices

At the request of the Bills Committee on Smoking (Public Health) (Amendment) Bill 2005, the Administration undertook to examine the viability of prohibiting the use of tobacco brand name and logo on non-tobacco products.
