**6. Study on non-tobacco products that share the same trade mark as tobacco products**

At the request of the Bills Committee on Smoking (Public Health) (Amendment) Bill 2005, the Administration undertook to examine the viability of prohibiting the use of tobacco brand name and logo on non-tobacco products.

The Administration was requested to report to the Panel after it had completed an evaluation study of the campaign to promote healthy eating habit among school children at the end of the 2006-2007 school year and to take into account members' views and suggestions in the comprehensive review of the campaign.

**8. Eligibility for subsidised public benefits of non-eligible persons (NEPs) whose spouses are Hong Kong residents and those who are not**
