I. Meeting with the Administration

(LC Paper No. CB(2)2625/07-08(01))

The Subcommittee deliberated (index of proceedings attached at Annex).

- 2. The Administration was requested -
 - (a) to provide more detailed information concerning training materials for the Police officers on how a search should be conducted; and
 - (b) to provide information on the average police experience of a Divisional Commander and a Duty Officer of a Police station.
- 3. At the request of members, the Administration agreed -
 - (a) to consider spelling out clearly in the Police General Orders (PGO) and Force Procedures Manual (FPM) that only persons whose presence was necessary for conducting a search would be allowed to be present during a search;
 - (b) to consider spelling out explicitly in PGO and FPM that any request for a detainee to adopt a certain posture during a search should be subject to the necessity and proportionality tests;
 - (c) to consider spelling out explicitly in PGO and FPM the requirement for Police officers to keep accurate record of all searches; and

(d) to consider spelling out in FPM the handling arrangements set out in paragraph 14 of Annex B to the Administration's letter dated 17 July 2008.

4. The Subcommittee suggested that the Panel on Security should keep in view in the next term the development of the Lee Tung Street case and the Police's handling of the Police officers concerned.

5. <u>The Chairman</u> said that the Subcommittee had concluded its work and a report would be submitted, after endorsement by members, to the Panel on Security recommending that the issues raised by the Subcommittee be followed up by the Panel in the next term.

6. There being no other business, the meeting ended at 12:25 pm.
