NOISE CONTROL (CONSTRUCTION WORK DESIGNATED AREAS) (AMENDMENT) NOTICE 2008

(Made by the Secretary for the Environment under section 8A(1) of the Noise Control Ordinance (Cap. 400))

1. Commencement

This Notice shall come into operation on 1 January 2009.

2. Designated areas

- (c) the areas of Kowloon East and Tseung Kwan O hatched and enclosed in bold lines in Plan No. EPD/AN/K & NT-02 signed by the Secretary for the Environment and deposited in the Land Registry;
