當局非常支持尚未被環保徵費計劃涵蓋的零售業界舉辦一些減少使用膠袋的活動。環境及自然保育基金亦曾撥款資助在街市、報紙攤檔、麵包店及藥房減少使用塑膠購物袋的公眾教育活動。

2. 環境局局長樂意再一次與小組委員會會面,就重要的 議題進行討論。當局將會與小組委員會秘書聯繫,安排局長 出席其中一次將會舉行的會議。

「登記申請」表格的擬稿

- 3. 當局同意如在某零售店的經營者擁有「分行登記證」,便足以作為其中一個準則,藉此確立經營者是以第三者的身分在一個與寄主零售商的店鋪分隔開的另一間零售店經營業務。當局會相應地修改「登記申請」表格。
- 4. 「登記申請」表格的擬稿已在二月下旬供零售業界傳閱,業界亦正提交提議和意見予當局。這工作正持續進行。

給予「訂明零售商」誘因

5. 我們欣悉零售業界近期推廣「自備購物袋」及減少使用塑膠購物袋的工作。我們會繼續與業界攜手合作,以令環保徵費計劃得順利推行。

在第3、6、8條中「並非妥當作出」的片語

6. 當局同意考慮因應小組委員會的意見檢討有關的條 文。

署長決定的期限

- 8. 當局一直與業界保持緊密的合作,以確保環保徵費計劃能順利推行。就處理登記零售商為其新零售店所作的登記申請,當局已作出 10 個工作天的服務承諾,並進一步承諾會加快處理緊急個案。當局亦承諾在 21 個工作天內完成新申請的處理。業界普遍同意這個建議期限。
- 9. 就第 4、7、9條而言,署長可能需要向申請人索取澄清資料,而該情况在收到申請時未必能夠預见。例如申請人所提供的資料不清楚以至無法核證其申請,或申請各時所提交的零售店樓面平面圖,與環境保護署(保署)在實地考察時所見的真實擺設不符,署長在這類情况下便需向申請人索取澄清資料。如果在規例的第 4、7、9條列明固定期限,一些申請者若未能回應提交澄清資料的現的與關門,一些申請者若未能回應提交澄清資料的專求,例如申請人暫時不在香港,署長便可能需要拒絕有關申請人在不能預見情况下的特殊需要,並可能對業界造成困難。

第 5 條

10. 如在登記申請獲批准後,就申請而提供予署長的

資料有所變更,登記零售商須通知署長以確保有關登記資料得以更新和準確。因這些變更只涉及事實資料,而當變更發生時登記零售商亦應已知悉,我們認為需要申請人在變更發生後的 30 天內作出通知是合理的。業界普遍同意這個建議期限。

11. 因第 5 條是處理在登記申請獲批准後出現變更的情況,不遵守第 5 條將不會影響登記零售商的登記身分。

12. 當局現正準備規例的修訂,並會盡快向小組委員會提交修訂建議。
