### 《定額罰款(吸煙罪行)規例》

(由食物及衞生局局長根據《定額罰款(吸煙罪行)條例》 (2008 年第 26 號) 第 16 條訂立)

#### 1. 生效日期

本規例自食物及衞生局局長以憲報公告指定的日期起實施。

#### 2. 本條例第3及6條所指的通知書

- (1) 本條例第 3(1) 條所指的通知書,須符合附表中表格 1 的格式。
- (2) 本條例第6(2)條所指的通知書,須符合附表中表格2的格式。
- (3) 採用附表中表格 2 的通知書,只在簽上或印有代表主管當局行事的公職人員 的姓名的情况下,方屬有效。

#### 3. 定額罰款的繳付

- (5) 定額罰款如非按照本規例繳付,該定額罰款視作仍未繳付,而庫務署署長可 將如此繳付的數額退回給付款人。

- 4. Failure to pay or notify the Authority that you wish to dispute liability for the offence in accordance with this notice may result in an additional penalty being imposed.
