Consumer Council [LC Paper No. CB(2)404/08-09(01)]	The Director of Food and Environmental Hygiene (DFEH) should issue guidelines on food recall for the trade to follow, such as setting up consumer hotlines and providing channels for return of products and compensation to affected consumers.
Advisory Council on Food and Environmental Hygiene [LC Paper No. CB(2)404/08-09(02)]	There is a need for the Centre for Food Safety (CFS) to act in a more proactive manner in monitoring new or emerging food contaminants and pathogens through better collection of intelligence from various sources.
Hong Kong Medical Association [LC Paper No. CB(2)374/08-09(01)]	Urges early implementation of the Bill.
Hong Kong College of Community Medicine [LC Paper No. CB(2)374/08-09(03)]	Considers it necessary to provide wide powers to DFEH under the new section 78B.
Hong Kong Doctors Union [LC Paper No. CB(2)430/08-09(05)]	In making the section 78B orders, due regard should be given to minimising economic hardship on small and medium enterprises.

	The Administration should set up an independent body, similar to the UK Food Standard Agency, to make the orders.
Democratic Party [LC Paper No. CB(2)430/08-09(01)]	In view of the wide powers provided to DFEH under the new section 78B, guiding principles of the code of practice (CoP) to provide practical guidance in respect of the operation of the section should be spelt out in the Bill.
Association for Hong Kong Catering Services Management Ltd [LC Paper No. CB(2)430/08-09(03)]	DFEH should exercise prudence in exercising the powers under the new section 78B, having regard to the adverse impact on the catering trade.
	The Administration should only publicise that certain food supplied by a food establishment was problematic, after the results of food test have proved to be the case.
Hong Kong Retail Management Association [LC Paper No. CB(2)374/08-09(02)]	Appropriate checks and balances should be put in place to ensure prudent exercising of powers by DFEH under the new section 78B.
Hong Kong Food Council	Clear guidelines should be provided on the exercising of power by DFEH under the new section 78B. For instance, DFEH should make sure that the food on sale or supply in Hong Kong come from the same production line and batch number(s) and use the same ingredients from the same source as the food found to be problematic overseas, before making a section 78B order.
Maxim's Caterers Ltd	It is unclear whether DFEH would notify the trade before servicing of section 78B orders and publication in the Gazette, and that in doing so the food concerned have been tested to be problematic.

Kowloon Fruit & Vegetable Merchants Association Ltd	Concurs with other organisations from the food trade.
Hong Kong Federation of Restaurants & Related Trades	
Hong Kong Catering Industry Association	The Administration should reimburse the trade all costs incurred for complying with section 78B orders in the first instance. Should the food concerned be found to be problematic after food tests, the Administration could recover the money paid from the trade.

[LC Paper No. CB(2)430/08-09(03)]	Enforcement of the Bill should only apply to large food establishments, whereas small and medium food establishments should be educated on the need to ensure the food they supply is fit for human consumption, having regard to the adverse impact of the servicing of section 78B orders on the catering trade.
Hong Kong Catering Industry Association	The Administration should provide interest-free loans to help innocent traders whose businesses are adversely affected by the servicing of section 78B orders.
