I. Meeting with the Administration

The Bills Committee deliberated and completed clause-by clause examination of the Occupational Deafness (Compensation) (Amendment) Bill 2009 (the Bill) (index of proceedings attached at **Annex**).

- 2. <u>Members</u> expressed support for the Administration's proposal to further enhance the improvement measures, as detailed in the Administration's paper (LC Paper No. CB(2)375/09-10(01)). <u>The Administration</u> undertook to provide the relevant draft Committee Stage amendments (CSAs) to the Bill before the next meeting.
- 3. Mr LEE Cheuk-yan expressed strong reservation about the Administration's proposal to adjust the overall rate and proportions of distribution of the Employees' Compensation Insurance Levy (the Levy) as stipulated under the Employees' Compensation Insurance Levies Ordinance (Cap. 411). He held the view that the overall Levy rate should be maintained at the current level of 6.3%, as this would ensure the generation of sufficient levy income for distribution to the Occupational Deafness Compensation Board, the Occupational Safety and Health Council and the Employees Compensation Assistance Fund Board, and hence their financial viability and ability to perform their statutory functions or improve their services. The Administration was requested to consider Mr LEE's suggestion and provide a written response.

II. Date of next meeting

4. The Bills Committee agreed to hold the next meeting on 11 January 2010 at 2:30 pm to consider the Administration's outstanding response to drafting issues raised at the meeting on 11 November 2009, response to issues raised by members at this meeting and the Administration's proposed CSAs to the Bill.

The proposal was accepted by all parties concerned during consultations. The adjustments in the Levy rate would not affect the three statutory bodies in performing their statutory functions. The Administration considered the proposed adjustments reasonable and appropriate
