Action

I. Meeting with the Administration

[The Bill, LC Paper Nos. CB(2)2469/08-09(02) and CB(2)1620/09-10(01) to (02)]

The Bills Committee deliberated (index of proceedings attached at Annex).

- 2. <u>The Administration</u> took members through the Administration's papers setting out its response to issues raised at the meetings on 10 and 23 February 2010 as well as the Administration's proposed Committee Stage amendments ("CSAs") to the Arbitration Bill. According to the Administration, the proposed CSAs were primarily intended to address various issued discussed by the Bills Committee at the previous meetings.
- 3. <u>The Chairman</u> considered it unnecessary to provide for a definition of "respondent" in clause 2 of the Bill given that the term appeared only in the provisions of the UNCITRAL Model Law, although she held no strong views against the term and the proposed CSA to it. <u>The Chairman</u> also considered that the proposed CSA to clause 8(2) to add the reference to "other than section 2(5)" was unnecessary as the provision of section 2(5) was unambiguous. The Administration would consider the Chairman's view.
- 4. At the request of the Chairman, <u>the Administration</u> would consider further refining the Chinese rendition of "peremptory order" in the proposed CSAs to clauses 53(3) and 53(4).

Action

- 5. <u>Members</u> generally considered that the drafting of the proposed CSA to clause 60(5) could be revised to further improve the clarity of that clause. <u>The Administration</u> would revert to the Bills Committee on the proposed CSA to clause 60(5).
- 6. <u>Members</u> considered other CSAs proposed by the Administration acceptable. The legal adviser to the Bills Committee was requested to advise on the Chinese text of the Administration's proposed CSAs.

II. Any other business

- 7. On the legislative timetable, <u>the Administration</u> advised that it intended to resume the Second Reading Debate on the Bill at the next session.
- 8. <u>Members</u> agreed that the next meeting would be scheduled pending the Administration's response to the outstanding issues.
- 9. There being no other business, the meeting ended at 10:13 am.
