## A BILL

# To

Apply a sum not exceeding \$262,931,890,000 to the services of the Government in the financial year ending on 31 March 2010.

Enacted by the Legislative Council.

#### 1. Short title

This Ordinance may be cited as the Appropriation Ordinance 2009.

### 2. Authorization of appropriation

The appropriation in the manner expressed in the Schedule of a sum not exceeding \$262,931,890,000 from the general revenue for the services of the Government in the financial year commencing on 1 April 2009, and ending on 31 March 2010, is hereby authorized.
