The Chief Executive's Question and Answer Session

The Chief Executive attended the Council meeting.

When the Chief Executive was about to address the Council, Hon LEUNG Kwokhung crossed the floor of the Council. He attempted to give a piece of cardboard to the Chief Executive and also spoke aloud. The President told Hon LEUNG Kwokhung that the Secretariat staff would collect the cardboard and ordered him to return to his seat and stop speaking. Assisted by the Clerk and security staff, Hon LEUNG Kwokhung returned to his seat but remained standing and continued to speak aloud. After repeated orders by the President, Hon LEUNG Kwokhung sat down and stopped speaking.

The Chief Executive addressed the Council.

After the Chief Executive had addressed the Council, Hon LEUNG Kwok-hung stood up again and spoke aloud. The President ordered Hon LEUNG Kwok-hung to sit down but he attempted to leave his seat. The President warned Hon LEUNG Kwok-hung that he would be ordered to withdraw from the Chamber if he did not comply with the Rules of Procedure. As Hon LEUNG Kwok-hung ignored the President's warning and continued to speak aloud, the President ordered him to withdraw immediately from the Chamber. Hon LEUNG Kwok-hung ignored the President's order and crossed the floor of the Council to place the cardboard on the Chief Executive's lectern, and also continued to speak aloud. The cardboard was taken away by security staff. Hon LEUNG Kwok-hung, assisted by the Clerk and security staff, then walked towards the main doors of the Chamber to leave but continued to speak aloud while walking.

The President suspended the meeting at 3:15 pm.

The Council resumed at 3:17 pm.

Seven Members and Hon LEE Cheuk-yan asked questions and the Chief Executive replied. While the Chief Executive was answering Hon LEE Cheuk-yan's question, Hon WONG Yuk-man interrupted the Chief Executive by speaking aloud. Pursuant to the President's order, Hon WONG Yuk-man stopped speaking and the Chief Executive continued to reply to Hon LEE Cheuk-yan's question.

Another Member asked a question and the Chief Executive replied.

Hon Albert CHAN asked a question. While Hon Albert CHAN was asking the question, Hon WONG Yuk-man displayed a banana-shaped balloon. The President ordered Hon WONG Yuk-man to put down the balloon. Hon WONG Yuk-man then handed the balloon over to Hon Albert CHAN who swayed the balloon and continued to ask his question. The Chief Executive then replied to the question.

Hon Albert CHAN asked a supplementary question. While Hon Albert CHAN was asking the supplementary question, some members of the public in the Public Gallery yelled noisily. The President asked them to keep quiet. While the Chief Executive was answering the supplementary question, Hon WONG Yuk-man interrupted the Chief Executive by speaking aloud. The President ordered Hon WONG Yuk-man to stop speaking and warned him that he would be ordered to withdraw from the Chamber if he breached the Rules of Procedure again. Hon WONG Yuk-man stopped speaking and the Chief Executive continued to answer the supplementary question.

While Hon WONG Ting-kwong was called upon by the President to ask his question, Hon Albert CHAN stood up and spoke aloud. The President asked him to be mindful of his language and sit down. The President also reminded him that he would be ordered to withdraw from the Chamber if he breached the Rules of Procedure again. The President repeatedly ordered Hon Albert CHAN to sit down and pointed out that he was hindering other Members from asking questions, but Hon Albert CHAN remained standing and continued to speak aloud.

The President suspended the meeting at 4:02 pm.

The Council resumed at 4:04 pm.

The Chief Executive addressed the Council again.

The President stated that the Council had a set of very clear Rules of Procedure, which were made by Members of this Council pursuant to the Basic Law. He believed that Members were willing to comply with the Rules. He added that it was his duty as President to preside over meetings according to the Rules of Procedure.

Six Members asked questions and the Chief Executive replied.

When the Chief Executive was about to leave the Chamber, Hon WONG Yuk-man left his seat, crossed the floor of the Council to hand a book to the Chief Executive. The President asked Hon WONG Yuk-man not to do so. At this juncture, small pieces of paper were thrown from the Public Gallery over the Government Despatch Box and some members of the public in the Public Gallery also yelled noisily. In accordance with the President's order, security staff removed the people concerned from the Public Gallery.

Next Meeting

The President declared that the next meeting of the Council would be held on 4 February 2009 at 11:00 am.

The Council was adjourned at 4:32 pm.
