1. Hon Audrey EU asked Question 1.

The Secretary for Food and Health replied.

Four Members asked supplementary questions and the Secretary for Food and Health replied.

2. Dr Hon LEUNG Ka-lau asked Question 2.

After Hon WONG Yuk-man had asked his supplementary question, Hon LEUNG Kwok-hung clapped his hands. The President asked him to keep quiet. The Secretary for Constitutional and Mainland Affairs replied.

While the Secretary was replying to the supplementary question, Hon WONG Yuk-man stood up to speak. The President asked him to sit down, but Hon WONG Yuk-man did not comply and continued to speak aloud. The President warned him that he had breached the Rules of Procedure and ordered him to sit down. As Hon WONG Yuk-man still did not comply, the President warned him again that he would be ordered to withdraw from the Chamber if he continued to act in breach of the Rules of Procedure. Hon WONG Yuk-man then sat down and stopped speaking. The Secretary continued to reply.

While the Secretary was still replying to the supplementary question, Hon WONG Yuk-man played a recording. The President ordered him to turn off the recording device immediately and warned him that he would be ordered to withdraw from the Chamber if he did not keep quiet immediately. Hon WONG Yuk-man then turned off the recording device. The Secretary continued to reply.

Hon LEUNG Kwok-hung asked a supplementary question and the Secretary for Constitutional and Mainland Affairs replied. Hon LEUNG Kwok-hung then asked a follow-up question and played the recording again. The President asked him to turn off the recording device and sit down. Hon LEUNG Kwokhung sat down and turned off the device. The Secretary replied.

Two other Members asked supplementary questions and the Secretary for Constitutional and Mainland Affairs replied.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

## **Motions**

<u>Proposed resolution under the Hong Kong Export Credit Insurance Corporation</u> Ordinance

The Secretary for Commerce and Economic Development moved the following motion and spoke on the motion:

RESOLVED that the contingent liability of the Hong Kong Export Credit Insurance Corporation under contracts of insurance shall not at any time exceed the sum of 30,000 million dollars.

Question on the motion proposed.

Hon WONG Ting-kwong declared that he was a member of the Advisory Board of the Hong Kong Export Credit Insurance Corporation, and then spoke on the motion.

Hon Jeffrey LAM declared that he was the Chairman of the Advisory Board of the Hong Kong Export Credit Insurance Corporation, and then spoke on the motion.

The Secretary for Commerce and Economic Development replied.

Question on the motion put and agreed to.

# **Members' Motions**

Proposed resolution under Article 75 of the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China

Hon TAM Yiu-chung moved the following motion and spoke on the motion:

RESOLVED that Rule 80 of the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region be amended —

(a) in paragraph (a), by adding "and" after the semicolon;

(b) in paragraph (b), by repealing "select committee(s) or investigation committee(s)" and substituting "select committee, investigation committee or any other committee".

Question on the motion proposed, put and agreed to.

# Procrastinating public consultation on constitutional development

Hon LEE Cheuk-yan drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting. A quorum was then present.

Hon Albert HO moved the following motion and spoke on the motion:

That this Council strongly condemns the Chief Executive Mr Donald TSANG Yamkuen for failing to honour his pledge made in the Policy Address by procrastinating public consultation on constitutional development, hence breaking faith with the people.

While Hon Albert HO was speaking, the President left the chair at 1:25 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon Albert HO's motion proposed.

The Secretary for Constitutional and Mainland Affairs spoke on the motion.

Seven Members and Hon Tommy CHEUNG spoke on the motion.

While Hon Tommy CHEUNG was speaking, Hon Albert HO raised a point of order on whether Hon Tommy CHEUNG's speech had deviated from the subject matter of the motion. The President's Deputy asked Hon Tommy CHEUNG to relate the points he made to the motion. Hon Tommy CHEUNG said that the points he made were related to the motion and continued to speak.

A Member and Ir Dr Hon Raymond HO spoke on the motion.

At 2:44 pm, while Ir Dr Hon Raymond HO was speaking, the President resumed the chair.

Seven more Members spoke on the motion.

Hon Albert CHAN spoke on the motion and played a recording. The President asked him to turn off the recording device. Hon Albert CHAN turned off the device and continued to speak on the motion.

Another Member spoke on the motion.

The Secretary for Constitutional and Mainland Affairs spoke again.

Hon Albert HO replied.

Question on Hon Albert HO's motion put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, four were in favour of the motion, 17 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 16 were in favour of the motion, eight against it and one abstained. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

## Relaxing the eligibility criteria for legal aid

Dr Hon Priscilla LEUNG moved the following motion and spoke on the motion:

That, as the high litigation fees in Hong Kong are beyond the means of the middle class in general, in particular cases for which appeals may be lodged to the Court of Final Appeal where the litigation fees incurred are often astronomical, it is not uncommon that middle-class people go bankrupt because of their involvement in legal proceedings, hence the provision of appropriate legal aid services to such middle-class people is very important; however, under section 5 of the existing Legal Aid Ordinance (Cap. 91), the asset limit for legal aid applicants is \$165,700, which is far below the actual need, rendering the majority of the middle class being excluded from the protection net of legal aid; if involved in litigation, the middle-class people are neither able to pay the high lawyer fees on their own nor eligible to apply for legal aid, they are therefore deprived of judiciary justice; on the other hand, the existing legal aid services only cover litigation cases in Hong Kong, and over the past two decades, a large number of Hong Kong permanent residents have been working and living in the Mainland, and it is very likely that they may get involved in legal proceedings in their daily lives, business operation or work, but they have nowhere to turn to for any legal assistance; in this connection, this Council urges the Government to:

- (a) conduct a comprehensive review on the existing legal aid system;
- (b) relax the asset limit for legal aid applicants (including that for the Supplementary Legal Aid Scheme) to a reasonable level so that more people in need are eligible to apply for legal aid; and

(c) extend the scope of the existing legal aid services to cover litigation cases in the Mainland involving Hong Kong permanent residents who are in the Mainland

Question on Dr Hon Priscilla LEUNG's motion proposed.

The President stated that three Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Dr Hon Margaret NG, who intended to move an amendment to the motion, spoke on the motion and the amendments.

While Dr Hon Margaret NG was speaking, the President left the chair at 4:33 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon Albert HO, who intended to move an amendment to the motion, spoke on the motion and the amendments.

At 4:42 pm, while Hon Albert HO was speaking, the President resumed the chair.

Prof Hon Patrick LAU, who intended to move an amendment to the motion, spoke on the motion and the amendments.

The Secretary for Home Affairs spoke on the motion and the amendments.

Nine Members spoke on the motion and the amendments.

Hon Albert CHAN declared that as he was being sued by a consortium. The lawsuit had dragged on for eleven years, and was still in progress. He then spoke on the motion and the amendments.

Dr Hon LEUNG Ka-lau declared that he was involved in a lawsuit against the Hospital Authority, and then spoke on the motion and the amendments.

Two more Members a spoke on the motion and the amendments

Hon Paul CHAN declared that he was the Chairman of the Legal Aid Services Council, and then spoke on the motion and the amendments.

While Hon Paul CHAN was speaking, Dr Hon Margaret NG sought, with the President's permission, elucidation by Hon Paul CHAN on whether his remarks on the independence of legal aid were made in his personal capacity or in a capacity as representing the Legal Aid Services Council. Hon Paul CHAN elucidated and continued to speak.

Another Member spoke on the motion and the amendments.

Dr Hon Priscilla LEUNG spoke on the amendmernts

The Secretary of Home Affairs spoke again.

Dr Hon Margaret NG moved the following amendment to Dr Hon Priscilla LEUNG's motion:

To add "to uphold the rule of law, it is necessary to ensure that no one is unable to exercise his or her rights under the law for want of financial means, and" after "That,"; to delete "high" after "to pay the"; to add "and extend the scope of assistance" after "a reasonable level"; to delete "and" after "eligible to apply for legal aid;"; and to add "; (d) consider implementing the recommendations set out in the Report on Conditional Fees published by the Law Reform Commission in July 2007; (e) review the existing free legal advice service and set up community legal service centres; and (f) formulate principles for determining legal fees for criminal legal aid so as to establish a more professional criminal legal aid system" immediately before the full stop.

Question on Dr Hon Margaret NG's amendment to Dr Hon Priscilla LEUNG's motion proposed and put.

Dr Hon Margaret NG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, six were in favour of the amendment, eight against it and eight abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 15 were in favour of the amendment, one against it and six abstained. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Relaxing the eligibility criteria for legal aid" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Albert Ho moved the following amendment to Dr Hon Priscilla LEUNG's motion:

To add "and establish an independent body for assessing and approving applications for legal aid" after "legal aid system"; to delete "and" after "eligible to apply for legal aid;"; and to add "; and (d) consider amending the law to enable the Director of Legal Aid to waive the asset limit for application of legal aid in respect of litigation cases involving constitutional issues or significant public interest, in addition to that for litigation cases involving human rights issues" immediately before the full stop.

Question on Hon Albert Ho's amendment to Dr Hon Priscilla LEUNG's motion proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, six were in favour of the amendment, 10 against it and six abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 15 were in favour of the amendment, one against it and six abstained. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Prof Hon Patrick LAU moved the following amendment to Dr Hon Priscilla LEUNG's motion:

To delete "; and (c) extend the scope of the existing legal aid services to cover litigation cases in the Mainland involving Hong Kong permanent residents who are in the Mainland" immediately before the full stop.

Question on Prof Hon Patrick LAU's amendment to Dr Hon Priscilla LEUNG's motion proposed, put and agreed to.

Dr Hon Priscilla LEUNG replied.

Question on Dr Hon Priscilla LEUNG's motion as amended by Prof Hon Patrick LAU put and agreed to.

## **Next meeting**

The President declared that the next meeting of the Council would be held on 18 February 2009 at 11:00 am.

The Council was adjourned at 7:08 pm.
