### **Bills**

### First Reading

Appropriation Bill 2009

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

### **Second Reading**

Appropriation Bill 2009

The Financial Secretary moved the Second Reading and delivered his Budget speech.

Shortly after the Financial Secretary started his speech, Hon WONG Yuk-man held up a piece of cardboard. The President asked Hon WONG Yuk-man to put down the cardboard and he complied. The Financial Secretary continued to deliver his speech.

While the Financial Secretary was delivering his speech, Hon WONG Yuk-man suddenly walked across the floor towards the Financial Secretary. He stood by the side of the table in front of the President's podium, placed a piece of cardboard on the table and spoke aloud. The Financial Secretary stopped his speech as requested by the President. The President repeatedly ordered Hon WONG Yuk-man to return to his seat, while the Clerk, a steward and several security staff tried to guide him back to his seat. Hon WONG Yuk-man walked a few more steps to stand in front of the Financial Secretary, then leaned forward and tried to grab the Financial Secretary's folder containing his speech. He then swiped away the stand and other items on the Financial Secretary's desk. The President ordered Hon WONG Yuk-man to withdraw from the Chamber immediately. Hon WONG Yuk-man did not withdraw and returned to his seat. The President ordered him again to withdraw from the Chamber immediately, but he did not comply.

At this juncture, Hon LEUNG Kwok-hung walked across the floor towards the Financial Secretary, stood in front of him and spoke aloud. He then broke a bowl and kept speaking aloud. The President ordered him to stop such acts and withdraw from the Chamber immediately, while the Clerk, two stewards and several security staff tried to guide him away. At the same time, Hon Albert CHAN stood up and spoke aloud.

The President ordered Hon WONG Yuk-man, Hon LEUNG Kwok-hung and Hon Albert CHAN to withdraw from the Chamber immediately. The Clerk and security staff tried to escort them to leave the Chamber. The three Members did not leave and continued to speak aloud. The President suspended the meeting at 11:50 am.

The Council resumed at 11:55 am.

Before continuing with his speech, the Financial Secretary said that the conduct of Hon WONG Yuk-man and Hon LEUNG Kwok-hung had affected the proceedings of the Legislative Council and were regrettable. He hoped that Members could fully observe the Rules of Procedure and refrain from pointless acts playing to the gallery.

Dr Hon Margaret NG raised a point of order on whether the Financial Secretary might, without raising a point of order, make comments on the incident. The President responded that according to the practice of the Council, the President would not intervene with the content of the speech of a public officer as long as it was not in breach of the Rules of Procedure. The President said that he was of the view that the content of the Financial Secretary's speech was in order.

Hon LAU Kong-wah raised a question on whether Hon WONG Yuk-man, Hon LEUNG Kwok-hung and Hon Albert Chan were allowed to return to the Chamber. The President responded that in accordance with the Rules of Procedure, he had ordered the three Members to withdraw from the Chamber immediately and not to return for the remainder of the meeting.

The Financial Secretary continued to deliver his speech.

Question on the Second Reading proposed. In accordance with Rules 67 and 71 of the Rules of Procedure, the President adjourned the debate on the second reading of the Bill and referred the Estimates to the Finance Committee for examination.

# **Next Meeting**

The President declared that the next meeting of the Council would be held on 4 March 2009 at 11:00 am.

The Council was adjourned at 12:40 pm.
