Bills

Appropriation Bill 2009

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 25 February 2009 resumed.

The Secretary for Financial Services and the Treasury, the Secretary for Labour and Welfare, the Secretary for Commerce and Economic Development and the Secretary for the Environment spoke on the motion.

The Financial Secretary replied.

Question on the Second Reading put.

Hon Albert CHAN claimed a division. The President then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 57 Members were present, 33 were in favour of the motion, 22 against it and one abstained. (Voting record in Appendix I.) Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Appropriation Bill 2009.

In accordance with Rule 68 of the Rules of Procedure, the Committee first considered the schedule to the Bill.

Question that the sums for heads 21 to 28, 30, 31, 33, 37, 39, 42, 44 to 49, 51, 53, 55, 59, 60, 62, 63, 70, 72, 74, 76, 78, 79, 80, 82, 90, 91, 92, 94, 95, 96, 100, 106, 112, 114, 116, 118, 120, 121, 136, 137, 139, 140, 143, 147, 148, 155, 156, 159, 160, 162, 163, 166, 168, 169, 170, 173, 174, 180, 181, 184, 186, 188, 190 and 194 stand part of the schedule proposed, put and agreed to.

Question that the sum for head 122 stand part of the schedule proposed.

Hon James TO moved that head 122 be reduced by \$50,410,000 in respect of subhead 000 and addressed the Committee.

Four Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, three were in favour of the amendment, 20 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the amendment and nine against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the other provisions of the Appropriation Bill 2009 or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon James TO moved that head 122 be reduced by \$16,998,570 in respect of subhead 000 and addressed the Committee.

While Hon James TO was speaking, the Chairman left the chair at 1:45 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Two Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

At 2:00 pm, while the Secretary for Security was speaking, the Chairman resumed the chair.

Hon James TO spoke again.

Another Member spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon James TO spoke for the third time.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, three were in favour of the amendment and 22 against it; while among the Members returned by geographical constituencies through direct elections, 26 were present, 15 were in favour of the amendment and 10 against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon James TO moved that head 122 be reduced by \$80,000,000 in respect of subhead 103 and addressed the Committee.

While Hon James TO was speaking, the Chairman left the chair at 2:30 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Another Member and Hon Frederick FUNG spoke on the amendment.

At 3:20 pm, while Hon Frederick FUNG was speaking, the Chairman resumed the chair.

One more Member spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, three were in favour of the amendment, 19 against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 19 were in favour of the amendment and 10 against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that the sum for head 122 stand part of the schedule put and agreed to.

Question that the sums for heads 138, 141, 142, 144, 151, 152 and 158 stand part of the schedule proposed.

Hon Emily LAU moved that heads 138, 141 and 151 be reduced by \$2,680,000 respectively and that heads 142, 144, 152 and 158 be reduced by \$1,970,000 respectively in respect of subhead 000 and addressed the Committee.

Eleven Members spoke on the amendments.

A Member who had spoken spoke again.

Another Member spoke on the amendments.

Hon LEUNG Kwok-hung spoke again.

While Hon LEUNG Kwok-hung was speaking, the Chairman left the chair at 6:26 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Two more Members and Dr Hon PAN Pey-chyou spoke on the amendments.

At 6:57 pm, while Dr Hon PAN Pey-chyou was speaking, the Chairman resumed the chair.

With the Chairman's permission, Hon Cyd HO elucidated a point she had made in her earlier speech, which she considered was misunderstood by Dr Hon PAN Pey-chyou.

Another Member who had spoken spoke again.

One more Member spoke on the amendments.

One more Member who had spoken spoke again.

The Secretary for Constitutional and Mainland Affairs spoke on the amendments.

Hon Emily LAU spoke again.

Two Members who had spoken twice spoke again.

The Secretary for Constitutional and Mainland Affairs spoke again.

Two Members who had spoken thrice spoke again.

Question on the amendments put.

Hon Emily LAU claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, three were in favour of the amendments, 18 against them and four abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, 16 were in favour of the amendments, 10 against them and one abstained. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that the sums for heads 138, 141, 142, 151, 152 and 158 stand part of the schedule put and agreed to.

Hon LEUNG Kwok-hung moved that head 144 be reduced by \$121,000,000 in respect of subhead 000 and addressed the Committee.

Hon Frederick FUNG spoke on the amendment.

While Hon Frederick FUNG was speaking, the Chairman left the chair at 8:47 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Three Members and Hon Mrs Sophie LEUNG spoke on the amendment.

At 9:20 pm, while Hon Mrs Sophie LEUNG was speaking, the Chairman resumed the chair.

The Chairman said that he intended to complete all the proceedings relating to the Appropriation Bill 2009 that night. As it would probably be very late at night by then, he would then suspend the meeting and resume it at 9:00 am the following day to deal with the unfinished businesses on the Agenda.

Three other Members spoke on the amendment.

The Secretary for Constitutional and Mainland Affairs spoke on the amendment.

Hon LEUNG Kwok-hung spoke again.

Three more Members spoke on the amendment.

Question on the amendment put.

Hon Albert CHAN and Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 28 were present, two were in favour of the amendment, 25 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 17 were in favour of the amendment and 11 against it. (Voting record in Appendix VI.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon LEE Cheuk-yan raised a point of order on whether the Chairman would follow the usual practice of suspending the meeting and order that it be resumed the following day at 9:00 am to deal with the unfinished businesses on the Agenda. He added that as it was 10:40 pm already and a lot of Members were still waiting to speak, it might be two or three o'clock in the morning when all the proceedings relating to the Appropriation Bill 2009 were completed.

The Chairman said that the time taken for the proceedings relating to the Appropriation Bill 2009 had been longer than he expected. As it was not expected that the Council had to spend the whole morning on the following day to deal with the unfinished business on the Agenda, the meetings originally scheduled for the following day had not been re-scheduled, which included meetings with members of two District Councils. The Chairman added that he had fully considered the different options in respect of the arrangements for the meeting. After consulting some Members, he considered it most appropriate for the Council to complete all the proceedings relating to the Appropriation Bill 2009 that night, which would have the least impact on the other meetings scheduled to be held on the following day.

Dr Hon Margaret NG asked whether there was a time limit for the meeting in case the proceedings relating to the Bill could not be completed by midnight.

The Chairman said that if Members had strong views on when the meeting must be suspended, he would listen to them.

Hon LEUNG Yiu-chung expressed concern that the businesses on the Agenda might not be finished by the estimated time the following day, and the meetings scheduled on that day would still be affected.

Hon LEE Wing-tat and Hon CHEUNG Man-kwong also expressed concern that it might take many hours to complete the remaining proceedings of the Bill. Hon CHEUNG Man-kwong suggested that the meeting should be suspended immediately and then resumed in the morning of the following day to deal with the unfinished businesses on the Agenda.

Hon TAM Yiu-chung said that he supported the Chairman's decision to suspend the meeting when all the proceedings relating to the Appropriation Bill 2009 had been completed.

Hon WONG Kwok-hing suggested that the meeting should continue until all the business on the agenda were finished that night.

The Chairman said that the meeting should not continue with the discussion on the time arrangement for the meeting, and should proceed to deal with the items on the Agenda. When the Committee proceeded to a debate on the question that clauses 1 and 2 stand part of the Bill, he would ask the Chairman's Deputy to take the chair and he would consult Members on the time arrangement for the meeting.

Question that the sum for head 144 stand part of the schedule put and agreed to.

Question that the schedule stand part of the Bill put and agreed to.

Question that clauses 1 and 2 stand part of the Bill proposed.

Hon LEE Wing-tat spoke on the clauses.

While Hon LEE Wing-tat was speaking, the Chairman left the chair at 10:50 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Hon Albert HO spoke on the clauses.

At 11:15 pm, while Hon Albert HO was speaking, the Chairman resumed the chair.

The Chairman announced that he had decided not to suspend the meeting until all the businesses on the agenda had been finished, which would have the least impact on the other meetings scheduled on the following day.

Hon Cyd HO drew the attention of the Chairman to the absence of a quorum. The Clerk then indicated that a quorum was present.

Hon LEE Cheuk-yan asked whether the Chairman had made the aforesaid decision because the Chief Secretary for Administration had scheduled a meeting with a senior Chinese official the following day.

The Chairman said that while he was willing to discuss with Members outside the meeting, he hoped that Members would accept his decision.

Seven other Members spoke on the clauses.

Question that clauses 1 and 2 stand part of the Bill put.

Hon Albert HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that 58 Members were present, 34 were in favour of the motion and 23 against it. (Voting record in Appendix VII.) Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

The Council then resumed.

Third Reading

The Financial Secretary reported that

the Appropriation Bill 2009

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 58 Members were present, 34 were in favour of the motion, 22 against it and one abstained. (Voting record in Appendix VIII.) Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.

Motions

<u>Proposed resolution under the Product Eco-responsibility Ordinance and the Interpretation and General Clauses Ordinance</u>

The Secretary for the Environment moved the motion in Appendix IX and spoke on the motion.

Question on the motion proposed.

Hon Audrey EU spoke on the motion as the Chairman of the Subcommittee on Product Eco-responsibility (Plastic Shopping Bags) Regulation, and then in her personal capacity as a Member.

While Hon Audrey EU was speaking, the President left the chair at 1:04 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another Member and Hon Andrew LEUNG spoke on the motion.

At 1:23 am, while Hon Andrew LEUNG was speaking, the President resumed the chair.

Four more Members spoke on the motion.

The Secretary for the Environment replied.

Question on the motion put.

Hon WONG Yuk-man claimed a division. The President then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 39 Members were present, 35 were in favour of the motion and three against it. (Voting record in Appendix X) Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Next Meeting

The President declared that the next meeting of the Council would be held on 29 April 2009 at 11:00 am.

The Council was adjourned at 2:05 am on 23 April 2009.

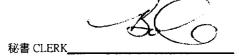

PRODUCT ECO-RESPONSIBILITY ORDINANCE AND INTERPRETATION AND GENERAL CLAUSES ORDINANCE

RESOLUTION

(Under section 29 of the Product Eco-responsibility Ordinance (32 of 2008) and section 35 of the Interpretation and General Clauses Ordinance (Cap. 1))

PRODUCT ECO-RESPONSIBILITY (PLASTIC SHOPPING BAGS) REGULATION

- RESOLVED that the Product Eco-responsibility (Plastic Shopping Bags)

 Regulation, made by the Secretary for the Environment on 31

 December 2008, be approved, subject to the following amendments
 - in section 2(1), in the Chinese text, in the definition of "登 記冊", by deleting the full stop and substituting a semicolon;
 - (b) in section 2(1), by adding —

 ""criteria for a Type 1 exemption" (第 1 類豁免準則)

 means the criteria specified in section 8(3);

 "criteria for a Type 2 exemption" (第 2 類豁免準則)

 means the criteria specified in section 8(5);

- "exempted area" (獲豁免範圍), in relation to a registered retail outlet, means an area of the retail outlet that is exempted by the Director for the purposes of section 23 of the Ordinance;";
- (c) by deleting section 3(4) and substituting
 - "(4) The Director may, by notice in writing, require the applicant to provide further information and documents in connection with the application.";
- (d) by deleting section 4(2)(a) and substituting
 - "(a) the applicant has not complied with a requirement under section 3(1), (3) or (4);";
- (e) in section 4, by adding
 - "(5) Before rejecting an application, the Director must
 - (a) give the applicant prior notice in writing of the Director's intention to do so and the reasons; and
 - (b) give the applicant an opportunity to make representations.";
- (f) by deleting section 6(4) and substituting
 - "(4) The Director may, by notice in writing, require the applicant to provide further information and documents in connection with the application.";
- (g) by deleting section 7(2)(a) and substituting
 - "(a) the applicant has not complied with a requirement under section 6(1), (3) or (4);";
- (h) in section 7, by adding
 - "(5) Before rejecting an application, the Director must –

- (a) give the applicant prior notice in writing of the Director's intention to do so and the reasons; and
- (b) give the applicant an opportunity to make representations.";
- (i) by deleting sections 8 and 9 and substituting –

"8. Application for exemption of part of the area of registered retail outlets or variation of exemption

- (1) For the purposes of section 23(2) of the Ordinance, a registered retailer may apply to the Director for the exemption of part of the area of a registered retail outlet of that retailer, or for the variation of an exemption, based on the criteria for a Type 1 exemption or the criteria for a Type 2 exemption.
- (2) An application under subsection (1) must be made in writing and in the specified form.
- (3) The following are specified as the criteria for a Type 1 exemption in relation to a registered retail outlet
 - (a) the total floor area of the retail outlet in which only non-specified goods are displayed or offered for sale is more than 50% of the retail floor area of the retail outlet; and
 - (b) each part of the area to be exempted is a cashier's counter

that accepts payment for nonspecified goods only.

- (4) For the purposes of subsection (3), "retail floor area" (零售樓面面積) has the same meaning as in Schedule 4 to the Ordinance.
- (5) The following are specified as the criteria for a Type 2 exemption in relation to a registered retail outlet
 - (a) the part of the area of the retail outlet to be exempted is used for the purposes of a business of a third party (not being the registered retailer) registered under the Business Registration Ordinance (Cap. 310);
 - (b) that area is demarcated clearly by a counter and is used exclusively for the purposes of the third party's business;
 - (c) the name, trade name, trade mark or brand name of the third party is displayed conspicuously in that area;
 - (d) that area is staffed by an employee of the third party; and
 - (e) all plastic shopping bags provided from that area bear the name, trade name, trade mark or brand name of the third party.

- (6) For an application based on the criteria for a Type 1 exemption, the specified form must be accompanied by a floor plan of the retail outlet indicating
 - (a) any area in which only nonspecified goods are displayed or offered for sale; and
 - (b) which part of the area of the retail outlet is intended to be exempted, or how an exempted area is intended to be varied, according to the criteria for a Type 1 exemption.
- (7) For an application based on the criteria for a Type 2 exemption, the specified form must be accompanied by a floor plan of the retail outlet indicating which part of the area of the retail outlet is intended to be exempted, or how an exempted area is intended to be varied, according to the criteria for a Type 2 exemption.
- (8) The applicant may, by giving the Director notice in writing, withdraw the application under this section at any time before it is determined under section 9.
- (9) If a change in the information provided to the Director under this section occurs before the determination of the application, the applicant must, as soon as reasonably practicable, give the Director notice of the change in writing unless the application has been withdrawn.

(10) The Director may, by notice in writing, require the applicant to provide further information and documents in connection with the application.

9. Determination of application for exemption or variation of exemption

- (1) For the purposes of section 23(3) of the Ordinance, the Director must approve an application under section 8 unless it is rejected under subsection (2).
- (2) The Director may reject the application if the Director considers that
 - (a) the applicant has not complied with a requirement under section 8(1), (2), (6), (7), (9) or (10);
 - (b) the information provided in relation to the application is incorrect or misleading; or
 - (c) the retail outlet does not meet the following
 - (i) if the application is based on the criteria for a Type 1 exemption, any of the criteria for a Type 1 exemption; or
 - (ii) if the application is based on the criteria for a Type 2 exemption, any of the criteria for a Type 2 exemption.

- (3) If an application is approved, the Director must
 - (a) for the purposes of section 23 of the Ordinance, exempt the part of the area of the registered retail outlet, or vary the exemption, as indicated in the application subject to the following conditions
 - (i) if the application is based on the criteria for a Type 1 exemption, all the conditions set out in subsection (4); or
 - (ii) if the application is based on the criteria for a Type 2 exemption, all the conditions set out in subsection (5);
 - (b) give the applicant notice in writing of the decision; and
 - (c) specify in the notice the conditions to which the exemption or the variation of the exemption is subject.
- (4) For the purposes of subsection (3)(a)(i), if the application is based on the criteria for a Type 1 exemption, the following are the conditions to which the exemption, or variation of the exemption, of part of the area of the registered retail outlet is subject –

- (a) the retail outlet continues to meet the criteria for a Type 1 exemption;
- (b) plastic shopping bags may be provided from such an exempted area without payment of the charge required by section 23(1) of the Ordinance only if
 - (i) they are provided to customers who make payment for non-specified goods in that area; and
 - (ii) the number of bags so provided is not more than necessary for carrying those goods; and
- (c) such other conditions as the Director may reasonably impose from time to time.
- (5) For the purposes of subsection (3)(a)(ii), if the application is based on the criteria for a Type 2 exemption, the following are the conditions to which the exemption, or variation of the exemption, of part of the area of the registered retail outlet is subject
 - (a) the retail outlet continues to meet the criteria for a Type 2 exemption;
 - (b) plastic shopping bags may be provided from such an exempted area without payment of the

charge required by section 23(1) of the Ordinance only if –

- (i) they are provided to customers who purchase the goods offered for sale by the third party concerned in that area; and
- (ii) the number of bags so provided is not more than necessary for carrying those goods; and
- (c) such other conditions as the Director may reasonably impose from time to time.
- (6) The Director must also give the applicant notice in writing of any conditions imposed under subsection (4)(c) or (5)(c).
- (7) Before imposing any conditions under subsection (4)(c) or (5)(c), the Director must
 - (a) give the applicant prior notice in writing of the conditions that the Director intends to impose; and
 - (b) give the applicant an opportunity to make representations as to why the conditions should not be imposed.
- (8) If an application is rejected, the Director must
 - (a) give the applicant notice in writing of the decision; and

- (b) include in the notice a statement setting out the reasons for the decision.
- (9) Before rejecting an application, the Director must
 - (a) give the applicant prior notice in writing of the Director's intention to do so and the reasons; and
 - (b) give the applicant an opportunity to make representations.
- (10) An exemption, or variation of an exemption, approved under this section applies only to the registered retailer by whom the application is made.";
- (j) in section 10, by renumbering subsection (5) as subsection(6);
- (k) in section 10, by adding
 - "(5) Before revoking an exemption under subsection (1), the Director must
 - (a) give the registered retailer prior notice in writing of the Director's intention to do so and the reasons; and
 - (b) give that retailer an opportunity to make representations.";
- (*l*) in section 11(1)(b), by deleting "9(5)(*a*)(iii)" and substituting "9(4)(*c*) or (5)(*c*)";
- (m) by deleting section 12(3) and substituting
 - "(3) The return in respect of a registered retail outlet for each quarter must contain the following information –

- (a) the total number of plastic shopping bags delivered to the retail outlet during that quarter, except for any bags to be provided from an exempted area of the retail outlet that is subject to the criteria for a Type 2 exemption;
- (b) the total number of plastic shopping bags provided directly or indirectly to customers during that quarter from
 - (i) the retail outlet; or
 - (ii) if there is an exempted area in the retail outlet, any area of the retail outlet that is not exempted; and
- (c) the total amount of levies payable for the bags referred to in paragraph (b).
- (4) In relation to a quarter in which the application for registration or deregistration in respect of a retail outlet is approved, the return for that quarter must also specify the date on which the retail outlet becomes registered or deregistered.";
- (n) by deleting section 14(a), (b) and (c) and substituting
 - "(a) the number of plastic shopping bags provided to a customer in each retail transaction of the retail outlet, except for any bags provided from an exempted area of the retail outlet;

- (b) the amount charged for those bags by the retailer under section 23(1) of the Ordinance;
- (c) the number of plastic shopping bags contained in each shipment of plastic shopping bags to the retail outlet, except for any bags to be provided from an exempted area of the retail outlet that is subject to the criteria for a Type 2 exemption; and
- (d) the number of plastic shopping bags procured by the retailer and relating to each shipment referred to in paragraph (c).".
