First Reading

Village Representative Election Legislation (Miscellaneous Amendments) Bill 2009 Merchant Shipping (Safety) (Amendment) Bill 2009

The Bills were read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Village Representative Election Legislation (Miscellaneous Amendments) Bill 2009

The Secretary for Home Affairs moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Merchant Shipping (Safety) (Amendment) Bill 2009

The Secretary for Transport and Housing moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Motions

Proposed resolution under the Legal Aid Ordinance

The Secretary for Home Affairs moved the following motion and spoke on the motion:

RESOLVED that the Legal Aid Ordinance (Cap. 91) be amended –

- (a) in section 5(1), by repealing "\$165,700" and substituting "\$175,800";
- (b) in section 5A(b)
 - (i) by repealing "\$165,700" and substituting "\$175,800";
 - (ii) by repealing "\$460,300" and substituting "\$488,400".

Question on the motion proposed.

Hon LEE Cheuk-yan spoke on the motion as the Chairman of the Subcommittee on Proposed Resolution under Section 7(a) of the Legal Aid Ordinance (Cap. 91), and then in his personal capacity as a Member.

Four Members spoke on the motion.

The Secretary for Home Affairs replied.

Question on the motion put and agreed to.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Dr Hon Joseph LEE moved the following motion and spoke on the motion:

RESOLVED that in relation to the —

- (a) Fixed Penalty (Smoking Offences) Regulation, published in the Gazette as Legal Notice No. 66 of 2009; and
- (b) Fixed Penalty (Smoking Offences) (Specification of Authorities and Public Officers) Notice, published in the Gazette as Legal Notice No. 67 of 2009,

and laid on the table of the Legislative Council on 29 April 2009, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 17 June 2009.

Question on the motion proposed, put and agreed to.

The 4 June incident

Hon James TO raised the issue that as Hon CHEUNG Man-kwong's and Hon Tanya CHAN's amendments mentioned matters which were clearly the responsibility of the Government of the Hong Kong Special Administrative Region, the Administration should designate public officers to respond to such matters.

The President stated that the Rules of Procedure provided that designated public officer might attend meetings of this Council, but the Rules did not provide that they must attend. The Administration had already informed the Secretariat prior to the Council meeting that no designated public officer would respond to the motion and any amendments thereto.

Hon James TO requested the President to make a last attempt to contact the Administration to see if it would designate public officers to attend the motion debate. He might propose to adjourn the motion debate until there were public officers attending the debate to speak on the policies within their purview.

The President stated that Hon James TO's request was not a procedural matter. As the Administration had replied that it would not designate any public officer to attend the debate, he considered that there was no justification to suspend the meeting so as to approach the Administration on this matter. Nevertheless, in the course of the debate, he would ask the Secretariat to convey Hon James TO's view to the Administration once more. If there was any change, he believed that the public officers designated by the Administration could join the debate in time.

Hon Albert HO drew the attention of the President to the absence of a quorum.

The President directed the Clerk to summon Members to the meeting. A quorum was then present.

Hon LEE Cheuk-yan moved the following motion and spoke on the motion:

That this Council urges that: the 4 June incident be not forgotten and the 1989 prodemocracy movement be vindicated. Question on Hon LEE Cheuk-yan's motion proposed.

The President stated that four Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the four amendments would be debated together in a joint debate.

Hon LEUNG Kwok-hung, who would move an amendment to the motion, spoke on the motion and the amendments.

While Hon LEUNG Kwok-hung was speaking, the President left the chair at 2:17 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon CHEUNG Man-kwong, Hon Albert HO and Hon Tanya CHAN who would move amendments to the motion, spoke on the motion and the amendments.

Seven Members and Hon Cyd HO spoke on the motion and the amendments.

While Hon Cyd HO was speaking, Hon CHIM Pui-chung said that he wished Hon Cyd HO to withdraw her earlier remarks on his speech, but was refused by Hon Cyd HO.

At 3:44 pm, while Hon Cyd HO was speaking, the President resumed the chair.

Nine other Members and Hon Emily LAU spoke on the motion and the amendments.

With the President's permission, Hon Paul CHAN elucidated a point he made earlier which he considered to be misunderstood by Hon Emily LAU.

Two more Members spoke on the motion and the amendments.

Hon LEE Cheuk-yan spoke on the amendments.

Hon LEUNG Kwok-hung moved the following amendment to Hon LEE Cheuk-yan's motion:

To delete "and" after "the 4 June incident be not forgotten" and substitute with ", the responsibility for the crackdown be ascertained,"; and to add ", political prisoners be released, one-party dictatorship be ended, and democratic elections by universal suffrage be held for the whole nation" immediately before the full stop.

Question on Hon LEUNG Kwok-hung's amendment to Hon LEE Cheuk-yan's motion proposed and put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, three were in favour of the amendment, 13 against it and six abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 19 were in favour of the amendment and nine against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "The 4 June incident" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon CHEUNG Man-kwong moved the following amendment to Hon LEE Cheuk-yan's motion:

To add ", and urges the Education Bureau to include the 4 June incident in 1989 in the junior secondary and new senior secondary curriculum guides for Chinese History" immediately before the full stop.

Question on Hon CHEUNG Man-kwong's amendment to Hon LEE Cheuk-yan's motion proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the amendment, seven against it and 11 abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 19 were in favour of the amendment and nine against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Albert HO moved the following amendment to Hon LEE Cheuk-yan's motion:

To add ", and urges the Central Government to endorse the principles and concepts of Charter 08, and stop detaining and keeping under surveillance the people who initiated and jointly signed the Charter, so as to prepare for the vindication of the 1989 prodemocracy movement" immediately before the full stop.

Question on Hon Albert HO's amendment to Hon LEE Cheuk-yan's motion proposed and put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, three were in favour of the amendment, 13 against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 19 were in favour of the amendment and nine against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Tanya CHAN moved the following amendment to Hon LEE Cheuk-yan's motion:

To add "; at the same time, this Council considers that the remarks about the 4 June incident made by the Chief Executive at the meeting of this Council on 14 May 2009 cannot represent the opinion of Hong Kong people as a whole, and also expresses grave dismay and anger at such remarks" immediately before the full stop.

Question on Hon Tanya CHAN's amendment to Hon LEE Cheuk-yan's motion proposed and put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, three were in favour of the amendment, 11 against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 19 were in favour of the amendment and nine against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon LEE Cheuk-yan replied.

Question on Hon LEE Cheuk-yan's motion put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the motion, seven were against it and 11 abstained; while among the Members returned by geographical constituencies through direct elections, 29 were present, 19 were in favour of the motion and nine against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Implementation of One Country, Two Systems

Hon Emily LAU moved the following motion and spoke on the motion:

That, it was reported in Wen Wei Po on 11 March 2009 that LI Guikang, Deputy Director of the Central Government Liaison Office ('the Liaison Office'), said at a group meeting of Hong Kong ('HK') members of the Chinese People's Political Consultative Conference ('CPPCC') held in Beijing on 10 March 2009 that the Liaison Office and the Special Administrative Region ('SAR') Government had reached a 10-point agreement to allow HK members of CPPCC to participate in the political affairs of the SAR, which includes: should there be suitable talents among the HK members of CPPCC, the SAR Government may appoint them to public offices or award them Medals of Honour; the SAR Government should accord them treatment according to protocol and provide venues for them to hold activities; if conducting visits in the Mainland, the SAR Government officials may approach them for company, etc; moreover, in January last year, CAO Erbao, Head of the Research Department of the Liaison Office, published an article entitled 'Hong Kong's Governing Forces under One Country, Two Systems' in Study Times, pointing out that there are two governing teams in HK; one is 'a team of the establishment of the HKSAR', comprising the Chief Executive, principal officials, Executive Council members and civil servants of various ranks, judges and other judicial officers, etc, while the other is 'a team of the Central Government and Mainland cadres engaging in Hong Kong affairs', comprising competent authorities and representative offices of the Central Government responsible for Hong Kong affairs or specialized in work related to Hong Kong, competent authorities of the Central Government responsible for other national affairs and policies, cadres the relevant mainland relevant and party of provinces/regions/municipalities having close ties with the HKSAR, as well as government cadres responsible for matters involving HK, so as to rationalize the comments and acts of the Liaison Office and various provincial, municipal and local governments to interfere in the HKSAR affairs; in this connection, this Council urges:

(a) the Central Government and SAR Government to solemnly clarify whether there is such a 10-point agreement and whether two governing teams exist in HK;

- (b) the Central Government to strictly abide by the Basic Law and require that no Central Government departments and local governments may interfere in the affairs which the HKSAR Government administers on its own; and
- (c) the Central Government to restrain the Liaison Office and other mainland officials from making impudent comments, so as to avoid creating confusion in governance and causing the public to worry and panic;

thereby implementing 'One Country, Two Systems', 'Hong Kong people ruling Hong Kong' and 'a high degree of autonomy'.

Question on Hon Emily LAU's motion proposed.

The Secretary for Constitutional and Mainland Affairs spoke on the motion.

Twelve Members and Hon Cyd HO spoke on the motion.

While Hon Cyd HO was speaking, the President left the chair at 7:14 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another Member spoke on the motion.

The Secretary for Constitutional and Mainland Affairs spoke again.

Hon Emily LAU replied.

At 7:37 pm, while Hon Emily LAU was speaking, the President resumed the chair.

Question on Hon Emily LAU's motion put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, one was in favour of the motion, 16 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, 19 were in favour of the motion and eight against it. (Voting record in Appendix VI.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Next meeting

The President declared that the next meeting of the Council would be held on 3 June 2009 at 11:00 am.

The Council was adjourned at 7:42 pm.
