### **Council meeting of 17 June 2009**

## Proposed amendments to motion on "Proposal on the constitutional reform in Hong Kong"

Further to LC Paper No. CB(3) 655/08-09 issued on 3 June 2009, Hon Cyd HO Sau-lan and Hon WONG Yuk-man have respectively given notice of their intention to move separate amendments to Hon LEUNG Kwok-hung's motion on "Proposal on the constitutional reform in Hong Kong" scheduled for the Council meeting of 17 June 2009. As directed by the President, Hon Cyd HO's and Hon WONG Yuk-man's amendments will be printed in the terms in which they were handed in on the Agenda of the Council.

- 2. To assist Members in debating the above motion and the two amendments, I set out below the procedure to be followed during the debate:
  - (a) Hon LEUNG Kwok-hung moves his motion;
  - (b) the President proposes the question on Hon LEUNG Kwok-hung's motion, and orders a joint debate;
  - (c) the President calls on the two Members, who intend to move amendments, to speak in the following order, but no amendment is to be moved at this stage:
    - (i) Hon Cyd HO; and
    - (ii) Hon WONG Yuk-man;

- (d) the President calls upon the designated public officer(s) to speak;
- (e) joint debate on the motion and the two amendments follows thereafter;
- (f) the President gives leave to Hon LEUNG Kwok-hung to speak for the second time on the two amendments;
- (g) the President calls upon the designated public officer(s) again to speak;
- (h) in accordance with Rule 34(5) of the Rules of Procedure, the President has decided that he will call upon the two Members to move their respective amendments in the order set out in paragraph (c) above. The President invites Hon Cyd HO to move her amendment to the motion, and forthwith proposes and puts to vote the question on the amendment;
- (i) after Hon Cyd HO's amendment has been voted upon, the President deals with Hon WONG Yuk-man's amendment to the motion; and
- (j) after Hon WONG Yuk-man's amendment has been dealt with, the President calls upon Hon LEUNG Kwok-hung to reply. Thereafter, the President puts to vote the question on Hon LEUNG Kwok-hung's motion, or his motion as amended, as the case may be.
- 3. For Members' ease of reference, the terms of the original motion and of the motion, if amended, are set out in the **Appendix**.

# Motion debate on "Proposal on the constitutional reform in Hong Kong" to be held at the Legislative Council meeting of Wednesday, 17 June 2009

### 1. Hon LEUNG Kwok-hung's original motion

That this Council urges the Government to enact legislation on referendum and conduct a referendum on the proposal on constitutional reform in Hong Kong, so as to realize the principle of a high degree of autonomy for Hong Kong people, allow Hong Kong people to decide on the selection of the Chief Executive and the election of all Legislative Council Members by universal suffrage in 2012, fully comply with the relevant requirements of the International Covenant on Civil and Political Rights of the United Nations, and return the political power to the people.

## 2. Motion as amended by Hon Cyd HO Sau-lan

That this Council urges the Government to enact legislation on referendum, provide resources for promoting civic deliberation before the conduct of each referendum to achieve the goal of deliberative democracy, and conduct a referendum on the proposal on constitutional reform in Hong Kong, so as to realize the principle of a high degree of autonomy for Hong Kong people, allow Hong Kong people to decide on the selection of the Chief Executive and the election of all Legislative Council Members by universal suffrage in 2012, fully comply with the relevant requirements of the International Covenant on Civil and Political Rights of the United Nations, and return the political power to the people.

### 3. Motion as amended by Hon WONG Yuk-man

That this Council urges the Government to enact legislation on referendum and conduct a referendum on the proposal on constitutional reform in Hong Kong, so as to realize the principle of a high degree of autonomy for Hong Kong people, allow Hong Kong people to decide on the selection of the Chief Executive and the election of all Legislative Council Members by universal suffrage in 2012, fully comply with the

relevant requirements of the International Covenant on Civil and Political Rights of the United Nations, and return the political power to the people; and this Council also appeals to the people of Hong Kong to demonstrate on 1 July the people's power and express their determination to fight for dual universal suffrage in 2012.
