# Subcommittee to Study Issues Arising from Lehman Brothers-related **Minibonds and Structured Financial Products**

Minutes of the first meeting held on Monday, 27 October 2008, at 9:30 am in the Chamber of the Legislative Council Building

#### I Election of Chairman

Mr Albert HO, the member who had the highest precedence in the Council among the members of the Subcommittee present at the meeting, presided over the election of the Subcommittee Chairman. He invited nominations for the chairmanship.

- 2. Ir Dr Raymond HO was nominated by <u>Dr Philip WONG</u> and seconded by <u>Mr Jeffrey LAM</u>. <u>Ir Dr Raymond HO</u> accepted the nomination. There being no other nominations, Ir Dr Raymond HO was elected the Chairman. <u>Ir Dr HO</u> took over the chair.
- 3. The Chairman invited nominations for the deputy chairmanship of the Subcommittee. Mr KAM Nai-wai was nominated by Mr James TO, and the nomination was seconded by Mr Ronny TONG. Mr KAM Nai-wai accepted the nomination. Dr Philip WONG was nominated by Mr Jeffrey LAM, and the nomination was seconded by Mr WONG Ting-kwong. There being more than one nomination, the Chairman announced a vote by secret ballot. After all the members present had cast their votes, the Chairman invited Mr James TO and Mr Jeffrey LAM, who had nominated the two candidates, to oversee the counting of votes.

- 4. <u>The Chairman</u> announced the voting result. Mr KAM Nai-wai and Dr Philip WONG had each received nine valid votes. Three members had abstained from voting. As the two nominees received the same number of votes, lots were drawn by the Chairman in respect of the two nominees. <u>The Chairman</u> exercised his casting vote in accordance with the lot drawn by him and declared Dr Philip WONG the Deputy Chairman.
- 5. <u>The Chairman</u> informed members that Dr David Li had advised in writing that he would withdraw from the Subcommittee with effect from 27 October 2008.

- 6. <u>Members</u> noted the Terms of Reference of the Subcommittee which had been endorsed by the House Committee on 17 October 2008.
- 7. <u>Members</u> considered and endorsed the proposed wording of the motion seeking to authorize the Subcommittee to exercise the powers conferred by section 9(1) of the Legislative Council (Powers and Privileges) Ordinance (Cap.382). With members' agreement, <u>the Chairman</u> said that he would move the motion at the Legislative Council meeting on 12 November 2008 and give notice by 28 October 2008.

### III The way forward

## The Subcommittee's proposed major areas of study

8. Question was raised as to whether the study to be undertaken by the Subcommittee would also cover structured financial products that were unrelated to Lehman Brothers. Some members including <u>Dr Margaret NG</u> and <u>Mr Ronny TONG</u> considered that in examining the efficacy or otherwise of the existing

regulatory regime and the alleged mis-selling by banks, the Subcommittee should not exclude from the scope of its study those structured financial products that were unrelated to Lehman Brothers. Some members including Mr CHAN Kam-lam and Mr Jeffrey LAM were concerned that given the background leading to the setting up of the Subcommittee, members should focus more on the recent fiasco which involved Lehman Brothers minibonds and structured financial products, as well as ways to assist the aggrieved investors. Other members including Dr Priscilla LEUNG, Mr Paul CHAN and Mr KAM Nai-wai commented that the Subcommittee's Terms of Reference, as currently worded, could provide the necessary flexibility for members to also make reference to structured financial products which were not related to Lehman Brothers. Members noted Assistant Legal Adviser 6 (ALA6)'s advice that a total of 19 banks were involved in the sale of the Lehman Brothers-related minibonds and structured financial products and such minibonds and products shared a similar basic structure typical of the genre of structured financial products about which members were concerned. A study of the Lehman Brothers-related products might already serve the purpose of acquiring an overview of the retail sales of the structured financial products and the associated problems.

- 9. Some members including Mr Albert HO, Mr James TO and Mr KAM Nai-wai pointed out that although the Subcommittee was not tasked to assist affected investors to claim compensation, the findings and recommendations of its study would provide highly useful information for future policy reviews and for aggrieved investors in taking their complaints forward. They also expressed the following views on the study approach:
  - (a) the Subcommittee should focus its study on Lehman Brothers-related minibonds and structured financial products with a view to identifying the shortcomings of the existing regulatory framework and the lessons learnt. The findings and recommendations formulated by the Subcommittee would apply generally to the regulation of structured financial products; and
  - (b) a study into the Lehman Brothers-related minibonds and structured financial products might suffice in scope as over 43 000 investors and as many as 19 banks were involved. To attempt to study other non-Lehman Brothers-related structured financial products might render the study long-drawn and its scope excessively wide.
- 10. Summing up, the Chairman said that members had agreed in principle that while the Lehman Brothers-related minibonds and structured financial products would be the focus of the Subcommittee's study, the Terms of Reference, as currently worded, would in no way prevent the Subcommittee from making reference to non-Lehman Brothers-related structured financial products and other incidental issues.
- 11. <u>Members</u> also suggested some amendments to the "Proposed major areas of study" in LC Paper No. CB(1)110/08-09(03) to better reflect the scope of the study

and clarify some of the issues to be studied. <u>The Chairman</u> advised that the "Proposed major areas of study" before members might be revised and fine-tuned and it was by no means the finalized version. He asked the Clerk to revise the proposed major areas of study where appropriate by incorporating members' concerns raised during the meeting and to circulate the revised version to members for their comments. <u>The Chairman</u> said that the revised version could be further discussed at the next meeting if members so wished.

(*Post-meeting note*: With the Chairman's concurrence, the Clerk circulated the revised proposed major areas of study to members vide LC paper No. CB(1)150/08-09 on 31 October 2008).
