- The Subcommittee completed study of the United Nations Sanctions Admin (Liberia) Regulation 2009. The Administration was requested to consider replacing the word "person" with "persons" in the caption of section 27 "Liability of person other than principal offender" under Part 8 on "Other Offences and Miscellaneous Matters".
- The Assistant Legal Adviser was requested to examine the legal and drafting aspects of the Chinese version of the United Nations Sanctions (Democratic Republic of the Congo) Regulation 2009 and the United Nations Sanctions (Liberia) Regulation 2009, and to report irregularity, if any, to the Subcommittee.
