Action

#### I. Arrangements for cross-boundary students

[LC Paper Nos. CB(2)386/09-10(01) to (02) and CB(2)452/09-10(01)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. In the light of an increasing number of cross-boundary students (CBS) who were Hong Kong residents living in Shenzhen and travelling to schools in Hong Kong daily, members expressed the following views
  - (a) the Administration should consider increasing the special quotas granted by the Government and the Mainland Authority to the coach operators for operating cross-boundary school bus services and extending the "on-board clearance" services to all cross-boundary school buses;

#### Action

- (b) the Administration should study the feasibility of increasing the number of trips per hour for school buses to access the Lok Ma Chau Spur Line (LMCSL) Public Transport Interchange (PTI) to cater for the transportation needs of CBS;
- (c) the Administration should study the reasons for the upsurge of the number of CBS, analyse their profiles, project the future needs of CBS, and put forward long-term measures to cope with the increasing demand from CBS for various services, such as cross-boundary transportation services, school places and other support services, in a holistic manner; and
- (d) the increasing number of CBS was attributed to the rise of number of cross-boundary marriages and the trend of more Mainland residents gave births in Hong Kong.

### 3. <u>The Administration</u> made the following responses –

- (a) the provision of cross-boundary school bus services was based on the information collected from schools concerned on the needs of the services. In the light of the service demand and after obtaining the agreement of the Mainland authorities, the HKSAR Government had increased the number of special quotas from 20 in the 2008-2009 school year to 42 in the 2009-2010 school year to cater for the needs of CBS;
- (b) the "on-board clearance" services were provided on a trial basis. Of the 10 trips of "on-board clearance" services per day, seven were provided to CBS at Sha Tau Kok Control Point and three were provided to CBS at Man Kam To Control Point. The services facilitated the entry/exit of CBS, especially those of tender age. The Administration might consider providing the service at other boundary control points (BCPs), if so warranted. The pilot arrangement was being reviewed by relevant bureaux/departments from time to time in the light of the actual needs of CBS and the practical experience in the pilot;
- the Government had made available two additional vehicle queuing spaces at LMCSL PTI in July 2009. Notably, there was an increase in the number of school buses allowed to enter LMCSL PTI, i.e. from eight trips per hour in the 2008-2009 school year to 12 trips per hour in the 2009-2010 school year. Notwithstanding this, the Administration would review the transport arrangements and study the feasibility of further increasing the number of car trips per hour in the next school year;

#### Action

- (d) there was an upward trend on the number of CBS attending kindergartens and primary schools in Hong Kong. The majority of CBS lived in Shenzhen with their Mainland mothers who were waiting for the issuance of One Way Permits. It was noticeable that the increase was also due to fact that more Hong Kong families had moved to live in Shenzhen and the implementation of the Pre-primary Education Voucher Scheme. The Government considered that the provision of cross-boundary school bus services, which could provide safe and convenient door-to-door transportation service for CBS, was an appropriate arrangement;
- (e) the overall school places in the North, Tai Po, Yuen Long and Tuen Mun Districts were sufficient to meet the demand of CBS;
- (f) to facilitate parents to arrange their children to stay on the Mainland for primary schooling, the Education Bureau had launched a pilot project to enable two schools for Hong Kong children in Shenzhen to participate in the 2008-2010 Secondary School Places Allocation System. Through the pilot project, eligible Hong Kong children studying in Primary Six in these two schools could be allocated a public sector Secondary One place in the secondary schools in Hong Kong in September 2010; and
- (g) the HKSAR Government offered a range of support services to CBS. In addition to learning support programmes, schools concerned were also providing counselling services to CBS and making special arrangements to facilitate CBS to take part in extra-curricular activities. They also organised parental education programmes for parents of CBS. Some teachers even paid home visits to their students living in Shenzhen.

#### Follow-up actions

## Admin 4. <u>The Administration</u> was requested to –

- (a) revert to the Subcommittee in due course on the plan and timing for extending the "on-board clearance" services to other BCPs;
- (b) provide figures on class level distribution of CBS in the schools concerned and information on the profiles of CBS and their parents, if available; and
- (c) consider conducting a thematic study on the profiles of CBS, including their family background, number of siblings and whether their parents were Hong Kong residents, etc, with a view to formulating the long-term plan to address the needs of CBS.

Action

(*Post-meeting note*: The Administration advised that it did not have information on the profiles of CBS' parents.)

#### II. Continuation of work of the Subcommittee

[LC Paper Nos. CB(2)386/09-10(03) and CB(2)452/09-10(02)]

5. <u>The Chairman</u> referred members to LC Paper No. CB(2)386/09-10(03) and sought members' views on the need for the Subcommittee to continue its work in the 2009-2010 session. As it was envisaged that the Subcommittee could not complete its work within a short period, <u>members</u> agreed that the approval of the House Committee (HC) should be sought for the Subcommittee to continue to work for further 12 months in accordance with Rule 26(c) of the House Rules. <u>The Chairman</u> added that a report would be made to HC on the justifications for continuing the work of the Subcommittee beyond the 12-month period.

### III. Any other business

- 6. <u>Members</u> agreed to discuss the population policy relating to the Mainland-HKSAR families and the use of subsidised obstetric services by Mainland women whose spouses were Hong Kong residents at the next meeting to be held on 19 January 2010. <u>Members</u> further agreed that the Chief Secretary for Administration, who was Chairman of the Steering Committee on Population Policy, should be invited to attend the meeting.
