5. The Subcommittee had completed its scrutiny work. It supported the Administration moving the motion on the proposed VOA resolution on 18 March 2009. The Chairman would make a verbal report on behalf of the Subcommittee at the House Committee meeting on 6 March 2009 and the Subcommittee would issue its written report before the deadline for amendment to the resolution, i.e. 11 March 2009.
