requested the Administration to include in the speech of the Secretary for the Environment to be delivered at the motion debate on the Amendment Regulation a report about the shortfall of VOC emission reduction by 35 tonnes for meeting the 2010 emission reduction target, pursuant to the proposed amendments to relax the maximum VOC content limits for regulated vehicle refinishing paints.

Way forward

4. <u>The Chairman</u> concluded that the Subcommittee had completed examination of the Amendment Regulation and would report its deliberations to the House Committee by circulation before 7 October 2009 which was the deadline for giving notice of amendments to the Amendment Regulation. <u>Members</u> noted that the Administration would move a motion at the Council meeting on 14 October 2009 to amend the Amendment Regulation.
