I. Meeting with the Independent Police Complaints Council and the Administration

The Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. The Subcommittee requested that -
 - (a) the Administration and the Independent Police Complaints Council (IPCC) should revert to the Panel on Security on the financial and staffing situation of the statutory IPCC as well as other outstanding issues arising from the discussions of the Bills Committee on IPCC Bill one year after the commencement of the IPCC Ordinance; and

- (b) the Police and IPCC should jointly consider improving the administrative arrangements for surprise observations conducted by IPCC members and observers, and revert to the Panel on Security one year after the commencement of the Ordinance.
- 3. <u>The Chairman</u> concluded that the Subcommittee had completed its scrutiny of the Independent Police Complaints Council Ordinance (Commencement) (No. 2) Notice 2009 (the No. 2 Commencement Notice) and a report of the Subcommittee would be submitted to the House Committee on 17 April 2009. He informed members that amendments to the No. 2 Commencement Notice, if any, should be made by the Legislative Council meeting on 6 May 2009, and the deadline for giving notice to move such amendments would be 27 April 2009.
