- (a) provide a written response to clarify the meaning and coverage of "the means of transport of the consular post and of consular officers" as set out in Article 28 (2) of the PRC/India Convention, and remind the law enforcement agencies of the Hong Kong Special Administrative Region Government of the interpretation of the provision;
- (b) provide a written response to specify the circumstances under which the receiving state should take measures to prevent any attack on the personal freedom and dignity of consular officers who should enjoy personal inviolability under Article 33 of the PRC/Russia Convention, and explain the meaning of "dignity" referred to in this provision; and
- (c) amend the Chinese text of section 3 of the Administration of Estates by Consular Officers Ordinance (Cap.191) to align its meaning with the English text.
