Progress update on the support measures for small and medium enterprises arising from the global financial turmoil

This paper updates Members on the support measures for small and medium enterprises (SMEs) since the last Panel meeting on 1 December 2008 and the special meeting on 10 December 2008.

SME Loan Guarantee Scheme (SGS)

(Details at LC Paper No. CB(1)77/08-09(01))

2. The enhancement measures for the SGS were implemented on 6 November 2008. As at 12 December 2008, 31 participating lending institutions (PLIs) have joined the enhanced SGS. A list of these PLIs is at the **Annex**. From 6 November to 12 December 2008, the Trade and Industry Department (TID) has received 224 loan guarantee applications from the PLIs, of which 149 have been approved¹, involving a total loan amount of \$545.9 million. The remaining 75 applications are being processed by TID².

Special Loan Guarantee Scheme (SpGS)

(Details at LC Paper No. CB(1)379/08-09(01))

3. Following approval by the Finance Committee on 12 December 2008 for the setting up of the SpGS with a commitment of \$100 billion, the scheme was launched on 15 December 2008. So far, eight PLIs have signed up for the scheme, including Bank of China (Hong Kong), Chiyu Banking Corporation, Dah Sing Bank, Hang Seng Bank, Shanghai Commercial Bank, Standard Chartered Bank (Hong Kong), the Bank of East Asia and the Hongkong and Shanghai Banking Corporation. We expect that the number of PLIs will increase in the coming weeks when more of them have completed the legal procedures.
