Information Note A

Information Note B

Contractual arrangements for adjustment of operation fee according to fluctuation in price indices

Contract provision

As a general provision under both landfill and refuse transfer station (RTS) contracts, the monthly operation fees for these waste facilities need to be adjusted in accordance with fluctuation of the price fluctuation index specified under the contract.

RTS

The adjustment shall be made with reference to fluctuation of the Consumer Price Index (B) published by the Census and Statistics Department. A sample of calculation formula according to which the charge rate per tonne are increased or decreased is provided below:

 $R2 = R1 \times B/A$

Where:

R2 is the increased or decreased charge rate per tonne

R1 is the charge rate per tonne as given in the Schedule of Charges, i.e. the rate tendered by the Contractor

B is the current index published by Census and Statistics Dept. from time to time

A is the base index at the time of tendering

If the current index (B) is greater than the base index (A), there will be a positive adjustment and vice versa.

Landfills

The adjustment shall be made with reference to fluctuation of Composite Index which is the combination of a number of indices [i.e. materials index (40%), labour index (25%) and CPI(B) (35%)] published by the Census and Statistics Department. A sample of calculation formula according to which the operation fee is increased or decreased is provided below:

 $OF2 = OF1 \times B/A$

Where:

OF2 is the increased or decreased Operation Fee

OF1 is the amount of Operation Fee calculated according to the tendered rate submitted by the Contractor at the time of tendering

- B is the current index published by Census and Statistics Dept. from time to time
- A is the base index at the time of tendering

If the current net index (B) is greater than the base index (A), there will be a positive adjustment and vice versa.
