Dear Mr. HO,

Thank you for your email below to the Director of Home Affairs dated 9 March 2009. I am authorised to give you a reply.

The Building Management (Amendment) Ordinance 2000 and the Building Management (Amendment) Ordinance 2007 introduced amendments to section 28 of the Building Management Ordinance (Cap.344) (BMO) to provide that an Owners' Corporation (OC) should procure and keep in force in relation to the common parts of the building and the property of the OC a policy of third party risks insurance. The details are set out in the Building Management (Third Party Risks Insurance) Regulation (Cap.344B) (the Regulation) which was passed by the Legislative Council in November 2007.

Since the passage of the Regulation by the Legislative Council, the Home Affairs Department have taken various measures to publicise the Regulation and encourage the procurement of third party risks insurance. In December 2008, the Home Affairs Department consulted the Panel on Home Affairs of the Legislative Council on the commencement date of the relevant legislation about procurement of third party risks insurance. In order to allow sufficient time for OCs to procure third party risks insurance if they have not done so, or if they have already procured insurance to ensure that their policies comply with legislative requirements, it was suggested that the commencement date of the relevant legislation be set at 1 January 2011.
