Re: Suggestions on the Development of Electronic Health Record System in Hong Kong

Further to the submission of Senior Citizen Home Safety Association dated March 3, I am writing in further support of developing an Electronic Health Record System in Hong Kong. We believe such a system will encourage and indeed, empower patients to focus on their personal healthcare. Equally important is that it will support greater continuity of care across the health care providers in all sectors, as well as enhancing the integration between health and welfare services to face the challenges of our ageing population.

As one of the long term care service providers in the welfare sector, we are rendering 24-hour emergency support and care services to over 65,000 users, mostly seniors, allowing them to live in the community safely. To render timely support to our users, we have been collecting health records from them, including written information from the hospitals and general practitioners they visit and informal information verbally informed by the users, like the over-the-counter medicines they purchase from the dispensary. We have now accumulated thousands of health-related records after serving more than 120,000 users over the past 13 years. Last year, we have further enhanced our services to render health advices to our elderly users newly discharged from hospitals, with the support of HA's PPI where our nurses can access the users' EPR after seeking their consents. Initial result of the service is encouraging. Users have expressed high satisfaction towards the service as they could get to know more about their health conditions and be able to handle their drugs more properly with the assistance of our nurses.

Our situation is not alone. There are hundreds of long term care service providers serving elders and chronically-ill patients, who are also keeping and updating valuable health-related records of their users everyday in the community.
