Dear Chairman and Panel members

Re: New statutory tolls for Tai Lam Tunnel but actual tolls unchanged

We would like to bring to your notice that we would keep the existing tolls of Route 3 Country Park Section unchanged despite the fact that the statutory tolls will be revised and gazetted tomorrow. The new statutory tolls will come into effect on 1 August.

Please be advised gazetting is a statutory procedure under the "Tai Lam Tunnel and Yuen Long Approach Road Ordinance". New statutory tolls could be gazetted if the Company's actual net revenue of a financial year falls short of the minimum estimated net revenue of that specified year¹. The actual tolls nevertheless are unchanged as we would continue to offer concessionary tolls which are far below the gazetted levels

As of the financial year ended 31 July 2008, the Company had an accumulated loss of over HK\$300 million and an outstanding loan of about HK\$4,500 million.

The following concessionary programmes currently in place would be continued:

- (1) \$25 for empty trailers
- (2) \$25 for heavy and articulated goods vehicles at midnight
- (3) \$10 for taxis without passengers at midnight
- (4) \$50 for light buses without passengers
- (5) \$50 for single-decked buses without passengers
