#### I. Election of Chairman and Deputy Chairman

- (c) the deliberations of the Administration in drawing up the land use plan of WKCD and the latest progress in this regard.

#### The West Kowloon Cultural District Authority (WKCDA)

- (a) measures to be taken by the Chief Secretary for Administration, also the Chairman of WKCDA, to establish a working relationship with LegCo and to be accountable to LegCo in discharging his responsibilities, in particular the operation of WKCDA;
- (b) progress in the establishment of the Consultation Panel prescribed in Section 20 of the West Kowloon Cultural District Ordinance (Cap.601);
- (c) accessibility of meeting papers and minutes of meeting of WKCDA to the public and members of the Joint Subcommittee;
- (d) appointment of the Chief Executive Officer, including selection criteria and procedures;
- (e) appointment of members to various Committees set up under WKCDA; and
- (f) an organization chart of WKCDA.
