Proposed overseas duty visit to the Republic of Korea and Taiwan by the Subcommittee on Poverty Alleviation

Purpose

This paper invites members to consider a proposal for the Subcommittee on Poverty Alleviation (the Subcommittee) to conduct an overseas duty visit to the Republic of Korea and Taiwan to study the experience of poverty alleviation and the development of social enterprises in these places.

Background

- 2. At the Subcommittee's meeting on 6 April 2009, a suggestion was made for the Subcommittee to conduct a duty visit to obtain first-hand information on the successful experience of combating poverty and developing social enterprises in Asia.
- 3. After considering the policies and measures on poverty alleviation and social enterprises in four selected places in Asia (namely, Japan, Singapore, the Republic of Korea and Taiwan), the Subcommittee agreed at the meeting on 9 June 2009 that it would conduct a duty visit to the Republic of Korea and Taiwan, with a view to facilitating members' study on the subject of poverty alleviation and development of social enterprises in Hong Kong in helping the unemployed and disadvantaged.

Objectives of the proposed visit

- 4. The objectives of the proposed visit are as follows
 - (a) to obtain first-hand information on the poverty alleviation strategies and measures put in place to help the disadvantaged groups;
 - (b) to study the experience in the development of social enterprises to provide job opportunities for the unemployed and disadvantaged, in particular their financing, operation and management; and

(c) to exchange views with the relevant parties involved in the formulation, implementation and monitoring of anti-poverty strategies, and the development and delivery of social enterprise projects.

Details of the visit

Proposed timing of the visit

5. To tie in with the Subcommittee's work plan, the proposed visit is tentatively proposed for mid to late July 2009. Taking into account the flight time and the schedule for visiting the organisations concerned and exchanging views with the relevant parties, it is suggested that the proposed visit lasts seven days from 19 to 25 July 2009.

Participants of the visit

6. A circular will be issued to invite Subcommittee members and other Members to indicate interest in joining the visit.

Proposed budget of the visit

- 7. As approved by The Legislative Council Commission, each Member is provided with an overseas duty visit account of \$55,000 for the purpose of duty visits outside Hong Kong organised by committees of the Council. The fund in the account is for use by the Member in a four-year term. Any expenditure incurred in excess of the available balance in a four-year term has to be paid by the Member personally.
- 8. A rough estimate of costs of the proposed duty visit has been prepared in the **Appendix**, on the assumption that the Subcommittee will visit the Republic of Korea and Taiwan for seven days in July 2009.

Advice sought

9. Subject to members' support for the Subcommittee to conduct the proposed duty visit, the Secretariat will work out the details of the proposed duty visit. Members are also invited to note that the permission of the House Committee will have to be sought on the proposed duty visit.
