#### I. Progress of development of social enterprises

[LC Paper Nos. CB(2)2068/08-09(01) and (02)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. <u>Members</u> expressed the following concerns
  - (a) given that most of the social enterprises (SEs) were operated by non-governmental organisations (NGOs) which lacked of personnel with a business mindset in running the business, many SEs were running at a loss and were unable to sustain. The long-term financial self-sufficiency and sustainability of SEs was an area of concern. The Administration should create an enabling environment for the development of SEs. For instance, it should consider offering tax concession, accepting applications for the Enhancing Self-Reliance Through District Partnership Programme (ESR Programme) from organizations which were yet to be recognized as non-profit making organizations under Section 88 of the Inland Revenue Ordinance (IRO) (Cap. 112);
  - (b) the Administration should formulate a long-term plan to encourage the business sector to participate in or collaborate with NGOs in setting up and running SEs. In addition to the ESR Programme and mentorship scheme, the Administration should organize Summit on SEs regularly to facilitate experience sharing between SEs and the business sector:
  - (c) the Administration should identify and reserve government services contracts for priority bidding by specific SEs in accordance with their size and nature of business. In addition to cleansing services contracts and gardening services contracts, the Administration might consider identifying some minor maintenance works and repairs in the Housing Department and relax the tender requirements for priority bidding by SEs. This apart, the Administration might consider specifying in the contract the need to employ a certain percentage of socially disadvantaged and to offer the minimum wage level to enhance the comparative advantages of SEs in bidding government services contracts;

- (d) the Administration should consider appointing a commissioner to be responsible for overseeing the development of SEs and setting up an advisory committee on formulating the overall strategies for the further development of SEs;
- (e) the Administration should consider introducing a registration regime for SEs and monitor the operation of SEs to ensure that profits were reinvested in the community for social objectives;
- (f) the Administration should consider subsidizing SEs by, say, 20% to 30% of the operation costs having regard to the fact that the creation of job opportunities by SEs for the socially disadvantaged would help bring down the expenditure on welfare indirectly; and
- (g) as most SEs did not have a track record or assets to use as collateral to secure loans from financial institutions to sustain the business after using up the seed grants, the Administration should consider providing loan guarantees and encouraging financial institutions to offer low-interest loans to SEs.
- 3. <u>Under Secretary for Home Affairs and Assistant Director/Home Affairs Department</u> made the following responses
  - (a) the ESR Programme aimed to provide seed grants for eligible organizations to run SEs during their initial operations. While the Administration welcomed the private sector to participate in operating SEs, applicants for the ESR Programme should be non-profit making organizations within the meaning of Section 88 of IRO so as to ensure the prudent use of public money;
  - (b) similar to commercial enterprises, SEs should operate like a business and be self-financing in their operation. The Administration would continue to organise and/or support NGOs to organise Summit on SE in order to enable participants from various sectors (e.g. business, NGOs and academics) to share their views on the development of SEs. Besides, the Administration would continue with the Social Enterprises Partnership Programme which provided a platform to enhance and facilitate partnership among different sectors of the community through a matching forum and the mentorship scheme under which entrepreneurs/professionals were linked up with SEs so that the former could offer voluntary professional and business advisory services to the latter;

- (c) the Administration had made concerted efforts in identifying suitable government services contracts for priority bidding by SEs. Under the pilot scheme launched in 2008, 38 cleansing services contracts were reserved for priority bidding by SEs, of which 33 would continue to be included in the scheme this year. This apart, 13 additional cleansing services contracts and seven gardening services contracts were identified for priority bidding by SEs in 2009-2010. As for maintenance contracts of the Housing Department, the existing tender requirements were devised taking into account the need to ensure the safety and quality of the works undertaken by contractors;
- (d) the Administration would continue to promote cross-sector collaboration and continue with publicity and promotional efforts to raise the public awareness of and the demand for products and services provided by SEs as well as provide sales platform for SE products and services. While it would continue with the four-pronged approach in promoting the development of SEs, viz. enhancing public understanding, strengthening support for SEs, promoting cross-sector collaboration and nurturing more social entrepreneurs, it would draw reference from the successful experience of overseas countries in the further development of SEs;
- (e) too much financial assistance to or regulation of the operation of SEs might hinder the healthy development of SEs which should be operated in accordance with commercial principles. Nonetheless, the Social Enterprises Support Unit was established under the Home Affairs Department to co-ordinate and implement various programmes and support measures for SEs; and
- (f) the ESR Programme aimed to provide seed grants for eligible organizations to run SEs during their initial operations. Since SEs should operate like a business, financial institutions would normally subject SEs to the same credential requirements applied to small and medium enterprises when loan applications were received from SEs. Having regard to the impact on the operation of SEs amidst the financial tsunami, the Administration had approved 16 applications from ESR SEs for additional grants.
- Admin 4. <u>The Administration</u> was requested to collate information, as far as practicable, on
  - (a) the operational experience of SEs under the ESR Programme (e.g. the number of SEs which were making a profit, a loss or breakeven) and the proportion of sustainable SEs; and

(b) the number of job opportunities arising from the award of government services contracts to SEs under priority bidding.

### II. Any other business

- 5. <u>The Chairman</u> said that the next meeting would be held in September 2009. Members would be informed of the meeting date in due course.
