## Select Committee to Inquire into Matters Relating to the Post-service Work of Mr LEUNG Chin-man

## 2<sup>nd</sup> Supplemental Witness Statement of Mrs Susan MAK LOK Suet-ling

I, Susan MAK LOK Suet-ling, worked as the Deputy Secretary for Development (Planning and Lands)1 in the Planning and Lands Branch ("PLB") of the Development Bureau ("DEVB") from 9 July 2007 to 11 February 2009. During the period, I was responsible for policy issues under the purview of the Lands and Planning Division of PLB. In preparing this 2<sup>nd</sup> supplemental statement, I set out the questions raised by the Select Committee in its Clerk's letter to me dated 20 April 2009 and then provide my answers to the best of my knowledge. I am attending the Senior Executive Fellows Programme of the John F. Kennedy School of Government in Boston, USA and do not have access to records of DEVB. For Question 1, the information in the answer was provided to me by colleagues in DEVB and I do not recall having handled any other application that is not on the list provided by DEVB colleagues. For Question 2, I can only provide the answer to the best of my recollection. I have also requested colleagues in DEVB to check the Bureau's records. The result of their checking is the same as my recollection as reflected in the first paragraph of my answer to Ouestion 2.

- Q1. The number of post-service work applications from former directorate civil servants that you have handled during your service as the Deputy Secretary of Development (Planning and Lands)1 in the DEVB with the following details
  - (a) the respective ranks of the applicants;
  - (b) whether the post-service work applied for was full-time or part-time, and paid or unpaid;
  - (c) the last bureau/department each applicant has served before leaving the Government, and the major duties he/she undertook in the position; and
  - (d) the nature of the post-service work applied for and the major duties and responsibilities of the work.

A1. Please see table at Annex.

- Q2. Whether there were any discussions on matters relating to Mr LEUNG Chin-man's application for taking up the post-service work with New World China Land Limited and termination of the appointment during the period from 1 August 2008 and 11 February 2009 (i.e. before you were posted to the Civil Service Bureau ("CSB") in February 2009): (a) between you and Mr Raymond YOUNG Lap-moon, Permanent Secretary for Development (Planning and Lands), and/or other officers in the DEVB; (b) between you and CSB; and (c) between you and other bureaux/departments. If yes, please provide the details including the dates, the form (e.g. formal/informal meetings, telephone conversation, emails, etc.), the content and relevant records.
- A2. I have not had any discussions with Mr Raymond YOUNG Lap-moon or other officers in DEVB, or with CSB or with other bureaux/departments on matters relating to Mr LEUNG Chin-man's application for taking up post-service work with New World China Land Limited (NWCL) and termination of the appointment during the period from 1 August 2008 to 10 December 2008 when LegCo decided to set up a Select Committee to inquire into the matter.

However, since LegCo's decision to set up a Select Committee to conduct inquiries into matters relating to Mr LEUNG's post-service work with NWCL and until 11 February 2009, I have been in touch with some relevant bureaux/departments (including CSB, DoJ, Buildings Department and Lands Department) for the purpose of compiling information and documents in response to the various requests from the Select Committee. I have also sought legal advice in respect of the Inquiry.

The announcement by NWCL on Mr LEUNG's appointment on 1 August 2008 had aroused much public and media concern and in the days immediately following, Mr LEUNG's involvement in the Hunghom Peninsula development had been widely reported in the media. During that time, I believe that I might have had some casual conversations with my colleagues in DEVB and other bureaux/departments on Mr LEUNG's employment with NWCL, but I cannot remember the content of such conversations nor can I recall with whom I had had such conversations.
