property to any encumbrance, it has not expressly clarified that non-compliance of the

new law would not trigger the Government's right of re-entry under the Land Grant. It

The Committee believes that the law should put the matter beyond doubt to prevent

unnecessary future litigation. In this regard, the Committee proposes adding at the end

of Clause 51A the phrase ", any provision in the Land Grant notwithstanding".

is undesirable to leave this issue as a subject for future disputes.
