2. The Bills Committee deliberated (Index of proceedings attached at **Appendix**).

### Committee Stage amendments (CSAs)

3. The Bills Committee examined the CSAs proposed by the Administration in relation to the Companies (Amendment) Bill 2010 and the Business Registration (Amendment) Bill 2010 tabled at the meeting. The Bills Committee agreed to the proposed CSAs, and requested the Administration to provide written confirmation on the two issues set out in paragraphs 4 and 5 below.

(Post-meeting note: The Administration's papers on its proposed CSAs were issued to members vide LC Papers No. CB(1)2214/09-10(01) CB(1)2286/09-10(01) on 17 June 2010.)

### Follow-up actions to be taken by the Administration

- 4. In relation to members' concern on whether the word "may" or "must" should be used in the proposed section 22A(1A) in clause 11(2) of the Companies (Amendment) Bill 2010, the Administration undertook to seek legal advice and confirm the appropriate word to be used in the section.
- 5. Regarding members' concern on whether the word "需" or "須" should be used in the proposed section 4(3) in clause 4(3) of the Business Registration (Amendment) Bill 2010, the Administration was requested to consider the appropriate word to be used in the section.

(*Post-meeting note*: The Administration's paper confirming its position on the above issues was issued to members vide LC Paper No. CB(1)2269/09-10(01) on 15 June 2010.)

### Way forward

- 6. The Bills Committee completed scrutiny of the Bills. <u>The Administration</u> indicated that it would give notice for resumption of the Second Reading debate on the Bills at the Council meeting on 7 July 2010.
- 7. <u>The Chairman</u> said that he would make a verbal report on the deliberations of the Bills Committee to the House Committee on 18 June 2010, and the written report of the Bills Committee would be issued thereafter. The deadline for giving notice on CSAs to the Bills would be 26 June 2010.

		ALA2 pointed out that Ms Miriam LAU had in a previous meeting expressed concern that in proposed section 22(3A) and 22A(1A), the word "may" was used for the Registrar of Companies (the Registrar) to direct a company to change its name, when the company "must" not be registered by certain names.	
		The Administration responded that at the time of registration of a company name, the Companies Registry's computer system might not be able to identify that the company name was one which would likely give the impression that the company was connected with the Central People's Government or the HKSAR Government requiring approval by the Registrar for the use of the name. If after registration, the company namewas found in subsequent Companies Registry's manual checking to be such kind of a name, the Registrar would decide whether the company should be allowed to use the name taking into consideration relevant factors, and hence the word "may" was used to provide the Registrar with the discretion.	
		Dr Margaret NG opined that the use of the word "may" in proposed section 22A(1A) was more appropriate, as it was a provision to empower the Registrar to give change-of-name directions, whereas the word "must" would imply the

Marker		imposition of a duty on the Registrar to do something, and there was no mention of any sanction if the Registrar failed to perform the duty.  The Administration responded that further legal advice would be sought regarding the use of the word "may" or "must" in proposed sections 22(3A) and 22A(1A).	The Administration to take action.

As such, the Administration would move CSAs to amend the proposed sections 346(2A) and 348BA(2) to simply empower the Registrar to serve a notice and issue a certificate respectively through electronic means.

		section, and the meaning of the two Chinese words was slightly different, in that the word "需" implied a need whereas the word "須" implied a duty. ALA8 pointed out that the Administration responded to a query by Mr Alan LEONG at a previous meeting that changing the word "shall" in the original section 4(3) to "may" in the proposed section 4(3) was only a change of drafting style in English and would not change the meaning of the word. Hence the Administration might consider to keep using the original Chinese word "須" in this section. Ms Miriam LAU opined that if a legal duty was implied, the use of the word "須" should be more appropriate.	
		The Administration responded that there was no intention to alter the legal effect with the change in the use of word. The Administration undertook to further consider the appropriate Chinese word to be used in the provision.	The Administration to take action.
