**Bills Committee on Competition Bill
Exemption Arrangements for Statutory Bodies under the Competition Bill**

Purpose

This paper briefs Members on the exemption arrangements for statutory bodies under the Competition Bill (“the Bill”).

Legal Framework for Exemption

2. Clause 3(1) of the Bill provides that Part 2 and Schedule 7 (relating to the competition rules), and Parts 4 and 6 (relating to enforcement by the Competition Commission (“Commission”) and the Competition Tribunal (“Tribunal”)) would not apply to statutory bodies or their activities unless the Chief Executive in Council (“CE in Council”) determines otherwise by way of regulations to be made under clause 5(1)(a) of the Bill (“Opt In”). Also, the CE in Council may, under clause 5(1)(b) of the Bill, make regulations to disapply the provisions relating to the competition rules and enforcement to non-statutory bodies or their specified activities (“Opt Out”). Regulations made under clause 5 of the Bill will be subject to negative vetting by the Legislative Council (“LegCo”).

3. Clause 5(2) of the Bill further provides that the CE in Council will have to be satisfied that all of the following four criteria are met before making the regulation under clause 5(1)(a) of the Bill with respect to a statutory body –

- (a) the statutory body is engaging in an economic activity in direct competition with another undertaking;
- (b) the economic activity of the statutory body is affecting the economic efficiency of a specific market;

- (c) the economic activity of the statutory body is not directly related to the provision of an essential public service or the implementation of public policy; and
- (d) there are no other exceptional and compelling reasons of public policy against making such a regulation.

4. For the purpose of the Bill, “statutory body” means a body of persons, corporate or unincorporate, established or constituted by or under an Ordinance or appointed under an Ordinance, but does not include a company incorporated under the Companies Ordinance (Cap. 32), a corporation of trustees incorporated under the Registered Trustees Incorporation Ordinance (Cap. 306), a society registered under the Societies Ordinance (Cap. 151), a co-operative society registered under the Co-operative Societies Ordinance (Cap. 33), or a trade union registered under the Trade Union Ordinance (Cap. 332). These pieces of legislation concern mainly vehicles of incorporation of private entities which, if not excluded, may fall under the definition of “statutory body”. We have built in these exceptions as we do not intend to exempt private companies and organisations.

Exemption and Non-exemption for Statutory Bodies

5. After reviewing the nature and activities of all statutory bodies falling within the definition in the Bill in consultation with the relevant bureaux and departments and the Judiciary, we propose that -

- (a) 575 statutory bodies should remain exempted in their entirety (**Annex A**); and

- (b) six statutory bodies should not be exempted (**Annex B**);

6. Annex A covers 575 statutory bodies identified as not meeting all four criteria in clause 5(2) of the Bill for Opt In, and they should thus remain exempted by virtue of clause 3(1) of the Bill. Amongst these 575 statutory bodies –

- (a) 415 of them do not engage in economic activities or have insignificant amount of economic activities. Many of them are advisory, regulatory, adjudicative / quasi-judicial/ appellate or administrative / governing bodies such as the Broadcasting Authority, the Immigration Tribunal, the Endangered Species Advisory Committee, Privacy Commissioner for Personal Data, etc.;
- (b) 160 statutory bodies engage in economic activities that are directly related to the provision of essential public services or the implementation of Government policy in such areas as education, healthcare, social welfare, public housing and trade promotion. Examples are the Aided, Direct Subsidy Scheme (“DSS”) and Caput schools, the Hospital Authority, Hong Kong Red Cross, the Hong Kong Housing Authority and the Hong Kong Trade Development Council.

7. The list at Annex B covers six statutory bodies which we propose to be made subject to the regulation of the Bill. They are considered to have met the cumulative criteria in clause 5(2) of the Bill for Opt In. To apply the Bill to the statutory bodies listed in Annex B, they would need to be specified by way of a regulation to be made by the CE in Council under clause 5(1)(a) of the Bill upon its enactment. The regulation so made will be subject to the vetting of LegCo. We will approach these statutory bodies and explain to them the Government’s proposal before the making of the relevant regulation.

Obligations of the Exempted Statutory Bodies

8. Statutory bodies are subject to public scrutiny. They should adhere to the competition rules even though they are not subject to the law. The Administration would seek to ensure that the exempted statutory bodies would not undertake anti-competitive activities unless there are justifiable causes. These bodies are also required by the Bill to offer assistance in investigations by the Commission (Part 3), proceedings or appeals before the Tribunal (Parts 5, 7, 10), and to comply with relevant rules on the use of confidential information (Part 8) as with other undertakings.

9. If any exempted statutory bodies are found to have breached competition rules, the Administration would request the statutory bodies concerned to rectify their anti-competitive behaviour. If these statutory bodies refuse to act as requested, the Administration may, subject to the fulfillment of the criteria in clause 5(2), consider invoking the power of clause 5(1)(a) of the Bill so that the competition rules and the enforcement provisions will apply.
