Competition Bill

Thank you for your letter dated 27 October 2011.

We appreciate the efforts of the Administration to propose certain amendments to the Competition Bill to address concerns raised by various sections of the community towards making the legislation more certain and implementable. In that regard, we note that some of the proposed amendments have reflected specific recommendations put forth in the HKAB's submission to the Bills Committee dated 23 November 2010 (HKAB Submission).

However, the proposed amendments do not address a number of other key concerns of HKAB and its member banks, notably, Recommendation 1 set out in the HKAB Submission and highlighted in a later submission to the Bills Committee dated 11 July 2011 (Supplementary Submission). We would respectively urge the Bills Committee to seek an amendment to the definition of "legal requirement" in section 2 of Schedule 1 of the Competition Bill so that conduct engaged in or agreements made in compliance with any requirements applicable under codes of practice, circulars, guidelines or other directions or guidance in any form issued or endorsed by a Government-approved regulatory or supervisory authority in Hong Kong (or a relevant supranational body) is excluded from the challenge under the Conduct Rules. We would refer you to details elaborated in the Supplementary Submission, a copy of which is attached for ease of reference.
