Competition Bill Exemption of Professional Bodies

Thank you for your letter of 13 September 2010. We have the following views and observation on the matters raised in your letter.

Whether the Institute is engaged in an economic activity in direct competition with another entity

We draw your attention to the objects of the Institute as set out in section 4 of the Hong Kong Institute of Architects Incorporation Ordinance (Cap.1147).

It can be seen that the Institute is concerned with the profession as a whole, and is not engaged in architectural practice for any individual client. It follows that there is no question of the institute being engaged in an economic activity in direct competition with another entity.

Whether the economic activity of the Institute is affecting the economic efficiency of a specific market

The activities of the Institute are only "economic" in the sense that expenses are incurred by the Institute. These expenses are mainly incurred in respect of administrative expenses and the organization of seminars, forums, conferences, site visits and tours in furtherance of the objects of the Institute. Such activities are academic in nature and can have no effect on a specific market.

Whether the economic activity of the Institute is directly related to the provision of an essential public service or the implementation of public policy

The answer is no. The furtherance of the objects of the Institute is related to building and construction in Hong Kong, but only in an indirect manner as the Institute itself is not an architectural practice.

Exceptional and compelling reasons against making such a regulation

Such a regulation should not be made in the case of the Institute in that It is in fact performing a public function, and it is wrong in principle to classify the activities of the Institute as economic activities which the Bill is intended to address.

If necessary we shall be happy to elaborate on the nature of the Institute and its activities in any appropriate forums or to provide supplementary comments in the coming 2-3 weeks where appropriate.

Finally, may we enquire whether HKIA enjoys the status of a "statutory organization" in the fullest sense of the interpretation in the context of the Bill?
