## Competition Bill: HKTDC Should Be EXEMPTED

This is Viveca CHAN, Chairman & CEO of WE marketing group, I am one of SME owners in Hong Kong to urge your consideration to EXEMPT Hong Kong Trade & Development Council (HKTDC) from the Competition Bill, in light of its immense contributions to Hong Kong over the past decades.
