		(b) the Bill would require any person, who, in the course of business, imported, acquired or supplied by wholesale food in Hong Kong to keep transaction records of the

In the case of fishermen who distributed their capture, they would be required to maintain capture records covering the date/period of the capture, the common name of the capture, the total quantity and the catch area. 		(c) licensing oyster farmers in Lau Fau Shan or fish pond owners was a separate issue and was not to be dealt with under the Bill. As requested by Mr WONG Yungkan, the Administration would reflect his views to the Secretary for Food and Health ("SFH") for consideration

		(b) like other Government fees, the registration and renewal fees of \$195 and \$180 respectively for a three-year term had been drawn up on a full-cost recovery basis; and	
		(c) so far, the Administration had not made any orders under section 78B of Cap. 132 and it would exercise this power with caution bearing in mind the impact to the trade. That said, it was important and necessary for the Administration to have such power to make orders to prohibit the import and supply of problem food and order a food recall when there was reasonable grounds to believe that public health was at risk
