Action

I. Meeting with the Law Society of Hong Kong and the Administration

[LC Paper Nos. CB(2)2045/11-12(01) and (02), CB(2)1715/11-12(01), CB(2)1520/11-12(01) and (02), CB(2)1417/11-12(01), CB(2)1182/11-12(01), CB(2)1311/11-12(01), CB(2)1333/11-12(01), CB(2)1258/11-12(01) to (03), CB(3)812/09-10, CB(2)1852/10-11(01), CB(2)1914/10-11(01), CB(2)2056/10-11(01) and CB(2)1938/10-11(02)]

Action

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. At the invitation of the Chairman, <u>Senior Assistant Solicitor General</u> ("SASG") briefed members on the Administration's latest discussions with The Law Society of Hong Kong ("LS") on the detail arrangements for the implementation of the top up insurance requirements, details of which were set out in the Administration's paper (LC Paper No. CB(2)2045/11-12(01)). Specifically, <u>SASG</u> said that the requirements would be similar and consistent as between Hong Kong limited liability partnerships ("LLPs") and foreign LLPs; it would not alter or amend the requirements of the primary insurance; it would not be subject to any limit as to the amount of liability for claims in the aggregate or as to the number of claims made against the partnership in any particular period; and the minimum indemnity amount might be substituted by an amount that was not less than HK\$10 million.
- 3. On members' concern about the safeguards to be put in place to ensure compliance with the top up insurance requirements by LLPs, SASG advised that the Administration would move Committee Stage amendments ("CSAs") to stipulate that if an LLP failed to comply with the top up insurance requirements at the time of default, its partners would not be entitled to LLP protection, albeit the firms could continue to operate in the form of a general partnership. In addition, the Administration would introduce consequential amendments to the Solicitors' Practice Rules (Cap. 159 sub. leg. H) and the Foreign Lawyers Practice Rules (Cap. 159 sub. leg. R) to enable LS to monitor compliance with the top up insurance requirements by LLPs. In gist, a principal of an LLP had to, within 14 days after the commencement of the business (for LLPs which were Hong Kong firms) or the establishment of a place of business by the firm (for LLPs which were foreign firms), as the case might be, provide LS with evidence of compliance with the top up insurance requirements. The principal also had to notify LS in writing within 14 days of occurrence if at any time the requirements were not complied with.

- 4. <u>The Chairman</u> requested the Administration to provide a full set of the draft CSAs to be moved by the Administration for the consideration of the Bills Committee at the next meeting.
- 5. At the invitation of the Chairman, <u>Mr Joseph LI of LS</u> said that the latest consensus was that the top up insurance requirements proposed by the Administration was an acceptable way forward. <u>Mr LI</u> further said that subsequent to the last meeting of the Bills Committee on 17 April 2012, LS had issued a circular to members on the top up insurance proposal and no

strong objection to the proposal had been received. However, a member had reservation about the premium rates.

- 6. <u>The Chairman</u> asked LS about the operation of the top up insurance. <u>Mr Joseph LI</u> advised that it would maintain a database to track the expiry dates of the top up insurance policies as notified by LLPs and send out renewal reminders to them.
- 7. The Chairman requested LS to provide after the meeting a paper on the operational details of the professional indemnity scheme and the top up insurance.

#### II. Date of next meeting

- 8. <u>The Chairman</u> reminded members that the next meeting would be held on 28 May 2012 at 8:30 am to consider the draft CSAs proposed by the Administration.
- 9. Due to the lack of a quorum, the meeting ended at 9:00 am.
