Action

Mr WONG Yung-kan, Chairman of the Establishment Subcommittee (ESC) in office, chaired the meeting. He informed members that the purpose of the meeting was to elect the Chairman and Deputy Chairman of ESC for the 2009-2010 session.

Election of Chairman

- 2. Mr WONG Yung-kan invited nominations for the chairmanship. Mr WONG Yung-kan was nominated by Dr PAN Pey-chyou and the nomination was seconded by Mr LAU Kong-wah and Ir Dr Raymond HO. Mr WONG accepted the nomination. As Mr WONG was nominated, Dr Margaret NG, Deputy Chairman of ESC in office, took over the chair of the meeting. Dr NG invited other nominations for the chairmanship.
- 3. There being no other nomination, Mr WONG Yung-kan was declared Chairman of ESC for the 2009-2010 session.

Election of Deputy Chairman

- 4. Mr WONG Yung-kan took the chair and invited nominations for the deputy chairmanship. Dr Margaret NG was nominated by Ms LI Fung-ying and the nomination was seconded by Mr LAU Kong-wah. Dr NG accepted the nomination.
- 5. There being no other nomination, Dr Margaret NG was declared Deputy Chairman of ESC for the 2009-2010 session.

Any other business

Application for late membership

The Chairman informed the meeting that Mr WONG Yuk-man had submitted an application to join ESC after the deadline for signification for The Clerk advised that in accordance with paragraph 3B of the membership.

Establishment Subcommittee Procedure, a request for late membership on grounds other than indisposition or absence from Hong Kong would be for the Subcommittee to decide. Members agreed to accept Mr WONG's application for late membership.
