#### Action

## **Election of Chairman**

- 2. <u>Ir Dr Raymond HO</u> invited nominations for the chairmanship of PWSC.
- 3. Ir Dr Raymond HO was nominated by Mr IP Kwok-him and the nomination was seconded by Ms Starry LEE and Mr WONG Kwok-kin. Ir Dr HO accepted the nomination. As Ir Dr HO was nominated for the chairmanship, Mr Alan LEONG, Deputy Chairman of PWSC for the 2008-2009 session, presided over the election of the Chairman.
- 4. There being no other nominations, <u>Mr Alan LEONG</u> declared that Ir Dr Raymond HO was elected Chairman of PWSC for the 2009-2010 session. <u>Ir Dr HO</u> then took over the chair.

## **Election of Deputy Chairman**

5. <u>The Chairman</u> invited nominations for the deputy chairmanship. Mr Alan LEONG was nominated by <u>Miss Tanya CHAN</u> and the nomination was seconded by <u>Mr CHAN Hak-kan</u> and <u>Mr WONG Kwok-hing</u>. <u>Mr LEONG</u> accepted the nomination.

6. There being no other nominations, the Chairman declared that Mr Alan LEONG was elected Deputy Chairman of PWSC for the 2009-2010 session.

7. <u>The Chairman</u> advised that in line with the current practice, the Administration would provide its forecast of submissions to the PWSC at the beginning of each legislative session. The 2009-2010 forecast would be circulated to members in due course.
