I. Confirmation of the minutes of the 22nd meeting held on 7 May 2010 (LC Paper No. CB(2) 1513/09-10)

The minutes were confirmed.

II. Matters arising

Report by the Chairman on her meeting with the Chief Secretary for Administration

2. <u>The Chairman</u> said that there was nothing special to report.

III. Business arising from previous Council meetings

- (a) Legal Service Division report on bills referred to the House Committee in accordance with Rule 54(4)
 - (i) Inland Revenue (Amendment) Bill 2010 (LC Paper No. LS 64/09-10)
- 3. <u>The Chairman</u> said that the Bill sought to give effect to two proposals concerning tax concessions in the 2010-2011 Budget, as follows -
 - (a) providing for one-off tax reduction to reduce the amount of salaries tax and tax under personal assessment payable for the year of assessment 2009-2010 by 75% or \$6,000, whichever was the lesser; and
 - (b) allowing more concessionary profits tax deduction for capital expenditure on environment-friendly vehicles.
- 4. <u>Mr KAM Nai-wai</u> considered it necessary to form a Bills Committee to study the Bill.
- 5. <u>The Chairman</u> proposed that a Bills Committee be formed to study the Bill in detail. <u>Members</u> agreed. The following Members agreed to join: Mr Tommy CHEUNG (as advised by the Chairman) and Mr KAM Nai-wai.
- 6. <u>The Chairman</u> said that the Secretariat would issue a circular to invite Members to join the proposed Bills Committee. Should less than three Members join the proposed Bills Committee by the deadline for signification of membership, the Bills Committee would not be formed. <u>Members</u> noted the arrangement.

(ii) Road Traffic (Amendment) Bill 2010 (LC Paper No. LS 65/09-10)

- 7. <u>The Chairman</u> said that the Bill sought to amend the Road Traffic Ordinance to introduce various measures to further deter drink driving offences. The Panel on Transport had been consulted on the legislative proposals at its meeting on 17 July 2009, and members had expressed diverse views.
- 8. In response to Mr Ronny TONG, the Chairman said that the Bill was not concerned with drug driving.
- 9. <u>Mr Andrew CHENG</u> considered it necessary to form a Bills Committee to study the Bill.
- 10. <u>The Chairman</u> proposed that a Bills Committee be formed to study the Bill in detail. <u>Members</u> agreed. The following Members agreed to join: Ms Miriam LAU, Mr Andrew CHENG and Mr Ronny TONG.
- 11. <u>The Chairman</u> said that as there were vacant slots, this Bills Committee and the Bills Committee on Inland Revenue (Amendment) Bill 2010 could commence work immediately.

- 12. <u>The Chairman</u> said that three items of subsidiary legislation, including two Commencement Notices, were gazetted on 7 May 2010 and tabled in the Council on 12 May 2010.
- 13. <u>Members</u> did not raise any queries on these items of subsidiary legislation.
- 14. <u>The Chairman</u> reminded Members that the deadline for amending the subsidiary legislation was 9 June 2010.

- 21. <u>The Chairman</u> said that the above motions would be moved by Mr Jeffrey LAM and Ir Dr Raymond HO respectively and the wording of the motions had been issued to Members.
- 22. <u>The Chairman</u> reminded Members that the deadline for giving notice of amendments, if any, to the motions was Tuesday, 18 May 2010.

Report on subsidiary legislation the period for amendment of which would expire on 26 May 2010

23. The Chairman said that the list of subsidiary legislation the period for amendment of which would expire on 26 May 2010 had been tabled at the

meeting. The Clerk had issued the relevant report to Members in the morning of the day of the House Committee meeting and invited Members to notify their intention to speak on the subsidiary legislation. The deadline for giving such notification was 12:00 midnight on Monday, 17 May 2010.

Bills - First Reading and moving of Second Reading

Food Safety Bill

24. <u>The Chairman</u> said that the Administration had given notice to present the above Bill to the Council. The House Committee would consider the Bill at its meeting on 4 June 2010.

VII. Report of Bills Committees and subcommittees

(a) Report of the Subcommittee on Proposed Senior Judicial Appointments

(LC Paper No. CB(2) 1514/09-10)

25. <u>Dr Margaret NG</u>, Chairman of the Subcommittee, reported on the deliberations of the Subcommittee the details of which were set out in its report. She reported that the Subcommittee supported the proposed appointments of Mr Justice Geoffrey MA Tao-li as the Chief Justice of the Court of Final Appeal ("CFA"), and Mr Justice Robert TANG Ching, Mr Justice Frank Stock and Mr Justice Michael John Hartmann as non-permanent Hong Kong judges to CFA. However, members had expressed grave concern about the appointment of three serving Justices of Appeal of the Court of Appeal of the High Court as non-permanent judges to CFA, and considered it necessary to conduct a review on the judicial manpower situation in CFA and other levels of courts. Members had also expressed reservation about the membership of the Secretary for Justice, being a Principal Official under the Political Appointment System, on the Judicial Officers Recommendation Commission. <u>Dr NG</u> added that the Panel on Administration of Justice and Legal Services would follow up on the relevant policy issues.

(b) Report of the Subcommittee on Dutiable Commodities (Exempted Quantities) (Amendment) Notice 2010

(LC Paper No. CB(1) 1867/09-10)

26. Mr CHAN Kin-por, Chairman of the Subcommittee, reported that the Subcommittee had held two meetings, including one to receive views from deputations.

- 27. Mr CHAN elaborated that the Notice specified the maximum number of duty-free cigarettes allowable for each incoming passengers to be 19 sticks. Some members requested the Administration to consider adjusting the cap to 20 sticks. The Administration explained that the policy intent was to abolish duty-free concessions on tobacco products brought into Hong Kong, and the purpose of exempting a small quantity of tobacco products for own consumption was to facilitate law enforcement and minimize nuisance to incoming passengers who smoked. In response to members' request, the Administration agreed to consider actively and carefully banning the sale of duty-free cigarettes at inbound duty-free shops. He added that the Subcommittee had also discussed issues relating to the enforcement and publicity of the Notice and the impact of tobacco control policy. He referred Members to the Subcommittee's report for details of its deliberations.
- 28. <u>The Chairman</u> reminded Members that as the deadline for amending the Notice was 2 June 2010, the deadline for giving notice of amendments, if any, was Wednesday, 26 May 2010.

VIII. Position on Bills Committees and subcommittees

(LC Paper No. CB(2) 1515/09-10)

- 29. <u>The Chairman</u> said that there were 10 Bills Committees, six subcommittees under the House Committee (i.e. two subcommittees on subsidiary legislation, one subcommittee on constitutional reform proposals, and three subcommittees on policy issues) and nine subcommittees under Panels in action.
- 30. <u>The Chairman</u> invited Members to note that the Bills Committee on Companies (Amendment) Bill 2010 and Business Registration (Amendment) Bill 2010, and the Bills Committee on Buildings (Amendment) Bill 2010 would have to work beyond three months since commencement of their work.

IX. Any other business

31. There being no other business, the meeting ended at 4:16 pm.
