# I. Confirmation of the minutes of the 23rd meeting held on 14 May 2010 (*LC Paper No. CB*(2) 1624/09-10)

The minutes were confirmed.

### II. Matters arising

# Report by the Chairman on her meeting with the Chief Secretary for Administration

2. <u>The Chairman</u> said that there was nothing special to report.

## **III.** Business arising from previous Council meetings

(a) Legal Service Division report on subsidiary legislation gazetted on <u>14 May 2010 and tabled in Council on 19 May 2010</u> (LC Paper No. LS 67/09-10)

3. <u>The Chairman</u> said that only one item of subsidiary legislation, i.e. the Electronic Transactions (Exclusion) (Amendment) Order 2010, was gazetted on 14 May 2010 and tabled in the Council on 19 May 2010.

4. <u>Members</u> did not raise any queries on this item of subsidiary legislation.

5. <u>The Chairman</u> reminded Members that the deadline for amending the subsidiary legislation was 9 June 2010.

# (b) Legal Service Division report on subsidiary legislation gazetted on <u>20 May 2010 and tabled in Council on 26 May 2010</u> (LC Paper No. LS 68/09-10)

6. <u>The Chairman</u> said that a total of 14 items of subsidiary legislation, including one Commencement Notice, were gazetted on 20 May 2010 and tabled in the Council on 26 May 2010.

7. Regarding the Tate's Cairn Tunnel Ordinance (Amendment of Schedule) Notice 2010, <u>the Chairman</u> said that the Panel on Transport had been consulted on the application for toll increase by the Tate's Cairn Tunnel Company Limited ("TCTC") at its meeting on 15 December 2009. TCTC proposed a \$1 toll increase for most vehicle types, representing increases ranging from 3% to 9%. She added that the Legislative Council had no power to amend the proposed level of increase, and Members could only propose minor technical amendments to the Notice.

<u>Action</u>

8. <u>Mr WONG Kwok-hing</u> considered it necessary to form a subcommittee to study the Notice.

9. <u>The Chairman</u> proposed that a subcommittee be formed to study the Notice in detail. <u>Members</u> agreed. The following Members agreed to join: Ms Miriam LAU, Mr WONG Kwok-hing and Mr IP Wai-ming.

10. Regarding the Solicitors (Professional Indemnity) (Amendment) Rules 2010, <u>the Chairman</u> said that it sought to enable the Hong Kong Solicitors Indemnity Fund Limited, authorized by a resolution passed by the Council of The Law Society of Hong Kong, to reduce the contributions to the indemnity fund payable by all solicitors firms (instead of the newly constituted firms) during an indemnity period.

11. <u>Dr Margaret NG</u> said that the Panel on Administration of Justice and Legal Services had planned to discuss the proposed amendments. However, the Amendment Rules were gazetted before the Panel had had the opportunity to discuss the legislative proposals. She considered it necessary to form a subcommittee to study the Amendment Rules.

12. <u>The Chairman</u> proposed that a subcommittee be formed to study the Amendment Rules in detail. <u>Members</u> agreed. The following Members agreed to join: Dr Margaret NG, Ms Miriam LAU, Ms Audrey EU and Ms Cyd HO.

13. <u>Members</u> did not raise any queries on the other 12 items of subsidiary legislation.

14. <u>The Chairman</u> reminded Members that the deadline for amending the subsidiary legislation was 23 June 2010.

15. <u>The Chairman</u> said that the report covered three items of subsidiary legislation, including the Dutiable Commodities (Exempted Quantities) (Amendment) Notice 2010, the period for amendment of which would expire on 2 June 2010. As a Member had notified his intention to speak on the Notice, she, as Chairman of the House Committee, would move a motion to take note of the report in relation to the Notice.

23. <u>The Chairman</u> said that the Subcommittee on Proposed Senior Judicial Appointments had reported to the House Committee at the last meeting, and Members did not raise objection to the proposed judicial appointments.

- (ii) Proposed resolution to be moved by the Secretary for Food and Health under the Pharmacy and Poisons Ordinance relating to:
  - the Pharmacy and Poisons (Amendment) (No. 2) Regulation 2010; and
  - the Poisons List (Amendment) (No. 2) Regulation 2010

(Wording of the proposed resolution issued vide LC Paper No. CB(3) 717/09-10 dated 24 May 2010.) (LC Paper No. LS 66/09-10)

24. <u>The Chairman</u> said that the proposed resolution was for seeking the Legislative Council's approval of the Pharmacy and Poisons (Amendment) (No. 2) Regulation 2010 and the Poisons List (Amendment) (No. 2) Regulation 2010 to add two substances to Division A of the First and Third Schedules to the Pharmacy and Poisons Regulations and to Division A of Part I of the Schedule to the Poisons List Regulations respectively.

25. <u>Members</u> did not raise objection to the Administration moving the proposed resolution at the Council meeting.

26. <u>The Chairman</u> said that the above motions would be moved by Mr Ronny TONG and Mr Andrew LEUNG respectively and the wording of the motions had been issued to Members.

27. <u>The Chairman</u> reminded Members that the deadline for giving notice of amendments, if any, to the motions was Wednesday, 2 June 2010.

Report on subsidiary legislation the period for amendment of which would expire on 9 June 2010

28. <u>The Chairman</u> said that the list of subsidiary legislation the period for amendment of which would expire on 9 June 2010 had been tabled at the meeting. The Clerk would issue the relevant report to Members and invite Members to notify their intention to speak on the subsidiary legislation. The deadline for giving such notification was 5:00 pm on Tuesday, 1 June 2010.

# VI. Report of Bills Committees and subcommittees

**Report of the Bills Committee on Inland Revenue (Amendment) Bill 2010** (*LC Paper No. CB*(1) 2057/09-10)

29. <u>Mr CHAN Kam-lam</u>, Chairman of the Bills Committee, reported on the deliberations of the Bills Committee as detailed in its report. He elaborated that the Bills Committee had held one meeting and had raised no objection to the proposed one-off reduction of salaries tax and tax under personal assessment by 75%, subject to a ceiling of \$6,000 per case. As regards the proposal for accelerating profits tax deduction for capital expenditure on environmental-friendly vehicles, the Bills Committee noted that the Environmental Protection Department would review annually the qualifying standards for remission of first registration tax for such vehicles. The Bills Committee had agreed that the issue of promoting wider use of environmental-friendly vehicles be referred to the Panel on Environmental Affairs for consideration.

30. <u>The Chairman</u> said that the Administration had indicated its intention to give notice for the resumption of the Second Reading debate on the Bill at the Council meeting on 9 June 2010.

# VII. Position on Bills Committees and subcommittees

(LC Paper No. CB(2) 1625/09-10)

31. <u>The Chairman</u> said that there were nine Bills Committees, eight subcommittees under the House Committee (i.e. four subcommittees on subsidiary legislation, one subcommittee on constitutional reform proposals, and three subcommittees on policy issues) and nine subcommittees under Panels in action.
