Paper for the House Committee meeting on 9 April 2010

Legislative Council delegation to conduct a duty visit to the Shanghai World Expo

Purpose

This paper seeks Members' views on the proposed duty visit to the World Exposition 2010 Shanghai China ("Shanghai Expo") by a delegation of Members of the Legislative Council ("LegCo") to be led by the President in response to an invitation of the Shanghai Municipal People's Government.

Background

Shanghai Expo

2. The Shanghai Expo will be held in Shanghai from 1 May to 31 October 2010 under the theme of "Better City Better Life". The Government of the Hong Kong Special Administrative Region (HKSAR) participates in the event by constructing a stand-alone Hong Kong Pavilion ("HK Pavilion"), participating in the Urban Best Practices Area Exhibition, and organizing a series of related activities such as Hong Kong week, parades and cultural performances.

3. On 9 May 2008, noting the support of the Panel on Commerce and Industry ("CI Panel"), the Finance Committee ("FC") accepted in principle the financial implications of supporting HKSAR's participation in the Shanghai Expo. On 6 June 2008, FC approved a commitment of \$145.40 million for the design and construction of the HK Pavilion. On 14 July 2008, FC further approved a non-recurrent commitment of \$201 million to meet the expenditure required for operating the HK Pavilion, the design and implementation of Hong Kong's

The five sub-themes are: blending of diverse cultures in the city; economic prosperity in the city; innovation of science and technology in the city; remodeling of urban communities; and rural-urban interaction.

Urban Best Practices Area Exhibition and for organizing various activities and events associated with Hong Kong's participation in the Shanghai Expo.

Proposed duty visit

- 4. At the House Committee meeting on 12 March 2010, Members noted that the President of LegCo had initiated a duty visit to the Shanghai Expo and agreed that the CI Panel should come up with its initial views on the proposed visit for the House Committee to consider at a special meeting to be held on 23 March 2010. Members attending the meeting of the CI Panel on 16 March 2010 expressed support for LegCo Members to conduct a duty visit to the Shanghai Expo. Views of Members on the timing and duration of the visit, itinerary and places to be visited as well as logistical arrangements were summarized in a paper for the House Committee vide LC Paper No. CB(1)1431/09-10 issued on 22 March 2010.
- 5. At the special House Committee meeting on 23 March 2010, Members expressed support for the CI Panel's suggestions on the proposed visit. Members agreed that the visit should take place as early as practicable in May 2010, and where possible, Members should be able to attend the opening ceremony of the Shanghai Expo on 1 May 2010. On the duration of the duty visit, Members agreed that to avoid clashing with other Council business, the visit could take place during a weekend and last for about three to four days. Members also agreed that the LegCo delegation should travel by the Express Rail Link on the Mainland en The itinerary should focus on the Shanghai Expo, including the HK Pavilion, the China Pavilion, the Urban Best Practices Area Exhibition, and other major highlights featured in the pavilions of other participating countries/places at the Shanghai Expo. Noting that visits to the Mainland would only materialize upon invitation by the Mainland authorities, the House Committee agreed that Members' views in relation to the proposed visit should be relayed to the Liaison Office of the Central People's Government in the HKSAR ("Liaison Office") through the President of LegCo.
- 6. Subsequent to the House Committee meeting, the President wrote to the Director of the Liaison Office conveying Members' views on the proposed visit. A reply was received from the Director of the Liaison Office on 31 March 2010. With the concurrence of the Chairman of the House Committee, the two letters were issued to Members vide LC Paper No. CB(1)1480/09-10 on 1 April 2010, and attached in **Appendices I and II**.

Proposed visit to the Shanghai Expo

7. According to the letter from the Director of the Liaison Office, the Shanghai Municipal People's Government welcomes the President of LegCo to lead all Members of the Legislative Council to visit the Shanghai Expo from 8 to 10 May 2010. The Ministry of Railways also welcomes the LegCo delegation to take the Wuhan-Guangzhou Express Rail Link. The Secretariat has since then been in

close contact with the Shanghai authorities and the Liaison Office on the visit programme and the logistical arrangements.

Itinerary and places to be visited

Hong Kong to Wuhan and Shanghai on 8 May 2010

8. Under the current plan, the delegation will take the Express Rail Link from Guangzhou to Wuhan at 11:10 am and take the 6:35 pm flight from Wuhan to Shanghai on 8 May 2010. To ensure Members could reach Guangzhou South Railway Station on time and to avoid the heavy traffic in Guangzhou city centre, Members will depart the LegCo Building at about 7 am and take ferry from the Hong Kong-Macau Ferry Terminal to Guangzhou Nansha Port, followed by coach to Guangzhou South Railway Station. During the journey from Guangzhou to Wuhan, relevant experts from the Ministry of Railways will brief Members on the operation of the Express Rail Link and its development in the Mainland. Afterwards, Members will take direct flight from Wuhan to Shanghai at 6:35 pm.

Visit to the Shanghai Expo on 9 and 10 May 2010

9. Members will have two full days in the Shanghai Expo, which is divided into two regions: the Pavilions region in Pudong and the Urban Best Practices Display Area region in Puxi. The delegation will visit the China Pavilion, the HK Pavilion, and the Theme Pavilions, as well as Pavilions of countries such as USA, United Kingdom and Japan on 9 May 2010. Visit to the Urban Best Practices Area where Hong Kong exhibits smart card technology and the effect of technology on everyday city life will take place on 10 May 2010. Subject to availability of time and confirmation by the relevant countries, a number of other pavilions may be included in the programme. The delegation will return to Hong Kong from Shanghai by air at 7:35 pm on 10 May 2010.

Media arrangements for the visit

10. Arrangement will also be made to enable press members on a self-paying basis to accompany the delegation throughout the visit. The maximum number of media representatives from each news organization covering the event is limited to three representatives for TV station (including one reporter, one cameraman and one technician) and one representative for each newspaper and radio station. The Public Information Division will liaise directly with media organizations on the detailed arrangements.

Financial arrangement

11. In accordance with the mechanism for handling Members' visits outside Hong Kong in response to invitations which was endorsed by the House Committee on 11 December 2009, visits related to LegCo business will be charged to individual Members' overseas duty visit ("ODV") accounts. A tentative estimate

of the expenditure for the 3-day visit is about \$9,500 per person, which is calculated according to the standard rates of subsistence allowance applicable to civil servants on duty visits to the city concerned and airfare at economy class rate. Subject to the House Committee's endorsement of the proposed visit, expenses relating to this visit will be charged to individual Members' ODV accounts.

Advice sought

12. Members are invited to consider whether to accept the invitation for the proposed visit and whether the expenditure of the visit should be charged to individual Members' ODV accounts.

议员希望能参观中国馆、香港馆、城市最佳实践区(包括香港及内地多个城市的参展方案),以及其它参与国家/地区展馆所展示的主要特色项目。议员亦希望顺道乘坐中国高速铁路,体验其实际运作和成效,并由相关的负责人员就这项运输建设及其发展作出介绍。

此外,亦有议员提出假如时间许可,希望能有机会参观上海市的城市建设及规划,以及拜访上海市金融服务办公室及相关的金融机构。
