At the Panel meeting held on 6 July 2004, the Administration was requested to conduct a review on the policy and procedures concerning the admission of industries into the industrial estates and the measures to ensure a level playing field and equitable treatment for interested parties seeking entry into the industrial Members requested the Administration to report the outcome of the review to the Panel in due course. Administration advised in June 2008 that the Hong Kong Science and Technology Parks Corporation (HKSTPC), which managed the industrial estates, was progressing with a strategic study on the revitalization of the industrial estates. The study would review, amongst other things, the admission criteria to the industrial estates and the admission mechanism. The study would be completed in the second quarter of 2010. The Administration would revisit relevant issues and provide a comprehensive report 15 June 2010 (To be confirmed)

to the Panel after HKSTPC's consultancy study was completed.

5. Annual progress report of the Research and Development Centres

The Administration will brief members on the annual progress reports from the Research and Development Centres.

6. Progress update on the implementation of the Road Cargo System

An electronic advance cargo information system for customs clearance of road cargoes (namely, the Road Cargo System (ROCARS)) is expected to be rolled out for trial run in late March 2010. The Administration will report to the Panel the progress made in encouraging early migration to ROCARS.
