Land Registry statistics for February 2010

The Land Registry today (March 2) released its statistics for February 2010.

Land Registration

- The number of sale and purchase agreements for all building units received for registration in February 2010 was 13,423 (+8.4% compared with January 2010 and +166.2% compared with February 2009)
- The 12-month moving average for February 2010 was 12,414 (this was 6% above the 12-month moving average for January 2010 and 60.6% above that for February 2009)
- The total consideration of sale & purchase agreements in February 2010 was \$48.7 billion (+8.9% compared with January 2010 and +206.7% compared with February 2009)
- Among the sale & purchase agreements, 11,733 were for residential units (+10.1% compared with January 2010 and +161.5% compared with February 2009)
- The total consideration for these sale & purchase agreements was \$40.8 billion (+12.8% compared with January 2010 and +199.4% compared with February 2009)

Sales of residential units refer to the sale and purchase agreements with payment of stamp duty. These statistics do not include sales of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme except those after payment of premium.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales are also released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

Land Search

 The number of searches of land registers made by members of the public in February 2010 was 369,873 (-25.1% compared with January 2010 but +21% compared with February 2009)

The statistics cover searches made at the counter, through the self-service terminals and the IRIS Online Services.



The Land Registry Chart showing the number of Sale and Purchase Agreements of building units from February 2009 to February 2010


