Legislative Council Panel on Health Services Healthcare Service Reform – Primary Care Development Strategy

At the meeting of the LegCo Panel on Health Services held on 12 July 2010, Members, in the context of discussing the Government's primary care development strategy, requested the Administration to provide a breakdown of the funding allocated or earmarked for various initiatives to enhance primary care; and information on how primary care pilot projects would be evaluated.

Funding Allocated or Earmarked for Primary Care

We have advised in the paper submitted to the Panel in July (paragraph 8 of LC Paper No. CB(2)1995/09-10(01)) that some \$2.9 billion has been earmarked for the period 2009-10 to 2012-13 to implement various initiatives in line with primary care development strategy, including a series of pilot projects to enhance support for chronic disease patients in the primary care setting, the Elderly Health Care Voucher Pilot Scheme, various vaccination subsidy schemes, establishment of community health centres or networks, enhancement of primary dental services and oral health promotion, etc. Implementation of many of these initiatives involves partnership between the public and private sectors or public-private partnership (PPP).

Taking into account new or existing funding for a number of additional initiatives relating to enhancement and development of primary care, including the

various vaccination schemes and enhancement of mental health services in the primary care setting, the total amount of additional funding allocated or earmarked for enhancement and development of primary care as a whole and promotion of PPP in healthcare from 2007-08 to 2013-14 stands at about \$4.1 billion¹. A breakdown of the \$4.1 billion funding allocated or earmarked for various primary care and PPP related initiatives are set out at *Appendix*.

Evaluation of Primary Care Pilot Projects

Development of primary care in Hong Kong is an on-going and evolving process. We have adopted a step-by-step and consensus-building approach to reforming the primary care system so that a virtuous cycle of pilot-evaluation-adjustment could be established for the continuous development and implementation of primary care initiatives. The newly established Primary Care Office under the Department of Health will be responsible for supporting and co-ordinating the development of primary care in Hong Kong, including the overall monitoring and assessment of the implementation of the primary care development strategy.

As part of the implementation of the primary care development strategy, individual pilot projects to enhance primary care will all be required to be subject to evaluation based on objective criteria with, where appropriate and necessary, independent and third-party assessment through partnership with academic institutions for instance. In particular, for pilot projects being implemented through the Hospital Authority to strengthen support for chronic disease patients in the primary care setting, the medical schools of the Chinese University of Hong Kong and the University of Hong Kong have been engaged as independent assessors to review and evaluate them against set service targets and performance indicators.

Implementing various vaccination schemes, including the Elderly Vaccination Subsidy Scheme which provides subsidy for elders aged 65 years or above to receive subsidised seasonal influenza and pneumococcal vaccinations, the Childhood Influenza Vaccination Subsidy Scheme which provides subsidy for children aged 6 months to 6 years to receive seasonal influenza vaccinations from private doctors, and the Human Swine Influenza Vaccination Programme.	1,600
